FINAL ANSWER-KEY AND RESULT OF THE CANDIDATES APPEARED IN OMR BASED PRELIMINARY TEST (PHASE-I) HELD ON DECEMBER 22, 2024, FOR RECRUITMENT IN THE CADRE OF DISTRICT JUDGE (ENTRY LEVEL) IN WBJS BY DIRECT RECRUITMENT EXAMINATION FROM MEMBERS OF BAR (DRB) AND LIMITED COMPETITIVE EXAMINATION FROM ELIGIBLE JUDICIAL OFFICERS (LCE) FOR THE YEAR 2024

In furtherance of this Court's Notification Nos. 7951-RG and 7952-RG, both dated 30.08.2024, read with Nos. 9272-RG and 9273-RG both dated 20.11.2024 with regard to the OMR based Preliminary Test (Phase - I) which was held on 22nd December, 2024 in the cadre of District Judge (Entry Level) in WBJS for direct recruitment from the members of the bar (DRB) and Limited Competitive Examination (LCE) from eligible Judicial Officers respectively for the year 2024, and after consideration of the objections raised by the candidates against some provisional answer-keys as regards to question nos. 1, 4, 6, 18, 24 and 25 published vide Notification No. 11528-RG dated 24.12.2024 in connection with the said OMR based preliminary test (Phase-I) for recruitment towards filling up of the vacancies in the above post and after evaluation of the OMR sheets of all the candidates of both wings, who appeared in the said test, the final answer-key of the questions of OMR based Preliminary Test along with four (4) Lists (List-I, List-II, List-III and List-IV) consist of Final Answer-key, result of all the candidates from the members of the Bar and the names of candidates of both wings qualified for Written Competitive Test (Phase-II), are being published for general information of all concerned.
