In continuation to this Office notice No. 1090/PSC, dt 14.02.2025, it is for information of all concerned that the Commission have decided to conduct the Physical verification of original certificates & documents and Viva Voce test simultaneously in respect of **54(fifty four) candidates** (bearing following Roll Nos.), qualified in the main written examination, for recruitment to the post of **Civil Judges(Junior Division) in Odisha Judicial Service-2023**, pursuant to Advt. No. 30 of 2023-24, **from 03.03.2025 to 07.03.2025(except holiday on 05.03.2025)** in the Office of the Commission, at 19, Dr. P.K. Parija Road, Cuttack - 753001, as per the following programme detailed below.

The candidates are required to come with hard-copies of online application forms (indicating their Roll Nos. at the top right corner), four passport size photographs, self-attested copies of all relevant certificates, documents, Proof of identity etc. **with originals of the same** as per **Para - 09** of the aforesaid Advertisement and duly filled in "**Attestation Form**" & "**Bio-data Form**" (to be downloaded from the website of the Commission) and submit the same **in person** on the day of verification.

It is also made clear that the candidature of these candidates for the recruitment is **purely provisional**. The candidature is liable to rejection in the event of inadequacy /deficiency found at any stage before or after the verification of original certificate /documents and is subject to fulfillment of terms and conditions laid down in the advertisement.

**Mere participation in the document verification does not reserve any right to appear the viva voce test.** The candidates shall be allowed to the viva voce test on the scheduled date & time mentioned below subject to fulfillment of their eligibility in all respect as per verification of original certificate /documents. The decision of the Commission thereon shall be final.
