Online applications (through email) are invited from eligible candidates for the post of **Project Research Scientist I**, purely on **contractual basis** in the extramural research project titled “**Targeting triple negative breast cancer by engineering agents derived from *Piper longum***”, sanctioned for up to 3 years from Indian Council of Medical Research, New Delhi under Dr. Subash Chandra Gupta, Professor and Head, Department of Biochemistry, AIIMS Guwahati. 4. Application should be mailed to above email IDs within 15 days of the publication of this advertisement on the AIIMS Guwahati website (<https://www.aiimguwahati.ac.in>) i.e. on or before 28.02.2025.
5. List of shortlisted candidates will be published on AIIMS Guwahati website before the interview. Any information/update regarding this advertisement including interview dates will be published on the official website of AIIMS Guwahati only in due course. Candidates are advised to visit the website regularly for updated information in this regard.
6. The interview will be conducted through offline mode only.
7. Place of Interview: AIIMS Guwahati
8. Candidates are required to bring one copy of application form and supporting documents (self-attested) as provided under checklist along with original documents for verification at the time of interview.
9. The decision of selection committee further to approval of Executive Director, AIIMS Guwahati will be final.
10. Result will be published on AIIMS Guwahati website after the selection process is over.

#### Terms and conditions

4. **Expiry of Contract:** The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
5. **Accommodation:** No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
6. The candidate already in government service shall submit '**No Objection Certificate**' from the present employer at the time of interview.
7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection. The Department may have specific requirement on the eligibility of candidates which will be adopted during the selection process.
8. One set of self-attested photocopies of the relevant documents would need to be emailed with the application form. The list of documents to be emailed is provided at the end of application form (check-list). In addition, candidates are required to bring one copy of application form and supporting documents (self-attested) as provided under checklist along with original documents for verification at the time of interview.
9. The candidate applying in response to this advertisement should satisfy themselves regarding their eligibility in all respects.

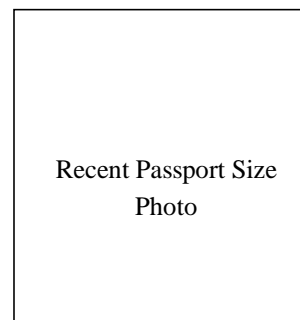
