


Advertisement for selection of PLVs

Applications are invited from the eligible local residents of Golaghat District only for selection of Para Legal Volunteers (PLVs) in the format attached.

Age__

: Minimum 18 (eighteen) years as on 01.01.2025.

Eligibility

- 1. PLVs shall be literate, preferably matriculate with a capacity for overall comprehension.
 - 2. Retired Teachers.
 - 3. Retired Government servants and senior citizens.
 - 4. Anganwadi Workers.
 - 5. Students & Law Students (till they enrol as lawyers).
 - 6. Members of non-political, service oriented NGOs and Clubs.
- 7. Members of Women Neighbourhood Groups, Maithri Sanghams and other Self Help Groups including of marginalised/vulnerable groups.
 - 8. Educated prisoners with good behaviour, serving long term sentences in prisons.
- 9. Any other persons whom the District Legal Services Authority or Taluk Legal Services Committee deems fit to be identified as PLVs.

Disqualification:

The PLVs shall be disqualified & Removes from the Panel if he/she:

- 1. Fails to evince interest in the scheme.
- 2. Has been adjusted insolvent.
- 3. Has been accused of an offence.
- 4. Has become physically or mentally incapable of acting as PLVs.
- 5. Has so abused his/her position or misconduct in any manner as to render his/her continuance prejudicial to the public interest.
 - 6. If he/she is an active political enthusiast of a political party.

Remuneration:

The work of PLVs do not carry any salary, remuneration or wages except honorarium fixed by the DLSA from time to time.

Job-profile:

PLVs should not look up to the income they derive from their services as PLVs, but they should have a mind set to assist the needy in the society coupled with Compassion, empathy and concern for the upliftment of marginalised and weaker section of the Society. They must have unflinching commitment towards the cause which should be translated into the work they undertake.

Process of Submitting Application:

The intending applicant shall fill up below attached form in his/her own hand legibly and shall annex relevant testimonials regarding his/her age, educational Qualification, Nationality & Resident status of Golaghat District. The top of the envelope containing the

application shall be highlighted in BOLD LETTERS "APPLICATION FOR SELECTION AS PLV". The application form shall be affixed with Two Passport Size Photographs (One Photograph to be pasted on the place assigned in the Form and the other should be stapled carefully so that the face of the candidate is not affected in the photograph). One self addressed envelope with Rs. 10/- (Rupees ten only) postal stamp shall also have to be submitted.

The selection of the PLVs will be made through an interview (viva-voce).

The applications should be sent to 'The Secretary, District Legal Services Authority, Golaghat, 1st Floor of the District Judicial Courts & Offices Golaghat. P/O & Dist- Golaghat, Pin-785621, Assam on or before 10 March, 2025 (by Post or by physically at the office itself).
