1. Essential Qualification:

Medical Practitioner from Army, Navy, Air-Force, Para Military, DGQA, DGAQA, DGNAI, DRDO, MES, CPWD & from any other Central Government services having a certificate of Training in Industrial Health of minimum three months duration. The syllabus of the course leading to the above certificate, and the organisations conducting the State Course shall be approved by the Directorate General of Factory Advice Service and Labour Institute (DGFASLI) or the Government in accordance with the guidelines issued by the D.G.FASLI.

Superannuated Medical Practitioners from Army, Navy, Air-Force, Para Military, DGQA, DGAQA, DGNAI, DRDO, MES, CPWD & from any other Central Government services having a certificate of Training in Industrial Health of minimum three months duration. 2. Period of Engagement and Age Criteria:

• The appointment is purely on contractual basis for an initial period up to 02 years or till the candidate attains the age of 72 years, whichsoever is earlier. The performance in terms of his/her specific role, charter of duties, responsibilities etc. will be monitored periodically and extension, if required, would be granted provided the performance is found to be satisfactory. Such extensions would be granted on yearly basis up to attaining the age of 72 years by the candidate.

3. Application Fee:

5. Certificates:

6. Mode of Selection:

The eligible candidates will be called for Interview and the selection will be done on the basis of performance in the Interview.

7. Criteria of Engagement:

i) Personnel with "Very Good" performance appraisal marks during the last 3 years of their service would only be eligible to be engaged on contract basis.

8. Terms of Engagement:

- i) The Medical Practitioner would be engaged only for the minimum period required.
- ii) He/She would be posted to OFN Dispensary and he/she would be functioning under the control of Chief General Manager/OFN.
- iii) The engagement will be on full time basis. Unauthorized Absence from duty will result in proportionate reduction in the Consolidated Emoluments.

9. Remuneration:

i) The Personnel engaged would be paid a Lumpsum Consolidated Remuneration per month.

10) Duties & Responsibilities :

- The Medical Practitioner shall be required to discharge the duties and responsibilities as per provisions contained in Factory Act, 1948 read with Bihar Factories Rules, 1950.
- The appointee shall perform the duties assigned to him/her. The Competent Authority reserves the right to assign any other duties as and when required. No extra/additional allowance will be admissible in case of such assignment.
- No Private practice of any kind is permissible nor is any non-practicing allowance admissible in addition to monthly remuneration.
- iv) The Medical Practitioner shall medically examine the workers to ascertain the physical fitness and health status at specified intervals.
- v) He shall also render Medical opinions as and when required.

11) Other Benefits and Term & Condition:
