





Age Relaxation and Additional Weightage of Marks for the applicants who are employees of the OSH & FW society:

- a) To avail the benefit of age relaxation and weightage, employees concerned should have completed at least three terms of contractual services (11 months each) under the OSH & FW Society.
- b) The remarks recorded in PAR of the employee concerned must be "Outstanding" or "Very good" for the proceeding 03(three) terms of contractual services under the OSH & FW Society.
- c) The age relaxation for the applied in respect of the employees of the OSH & FW Society shall be allowed @1 year for each contractual term of service in the Society up to a maximum of 10 years, over and above the maximum age limit prescribed in the Advertisement for the said post, subject to an age ceiling of 55 years.
