30.03.2025 (Sunday)	Language (English & Odia)	100 marks	10.00 AM to 12.00 Noon (120 minutes)	80 Questions will be MCQ Type carrying one Marks each to be held in OMR Sheet. Translation and Precis Questions will carry 20 Marks to be held in Question-Cum-Answer Booklet.
	General Studies	100 marks	03.00 PM to 04.30 PM (90 minutes)	100 Questions will be MCQ Type carrying one Marks each to be held in OMR Sheet.

**Note: There shall be negative marking @ 0.25 per each wrong answer for MCQ type Questions.**
