Depending upon number of applications received candidates will be shortlisted for written test/skill test Date, Time and Venue of test would be intimated to concerned candidates. When called, the candidates shall report for appearing in the interview with

- 3. Original and attested photocopies of all documents, certificates, degrees and mark sheets (Xth class onwards).
