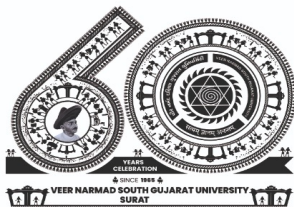

**UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018**

**I. Assistant Professor: Eligibility (A or B) :**

**A.**

- i) A Master's degree with 55% marks (or an equivalent grade on a point scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET, or who are or have been awarded a Ph. D. Degree by the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET :

*Provided*, the candidates registered for the Ph.D. program before July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

*The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.*

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR, or similar test accredited by the UGC, like SLET/SET.

**OR**

- B.** The Ph.D. degree has been obtained from a foreign university/institution with a ranking among the top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

*Note: The Academic score as specified in Appendix II (Table 3A) for Universities, and Appendix II (Table 3B) for Colleges, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.*

## **II. Associate Professor: Eligibility:**

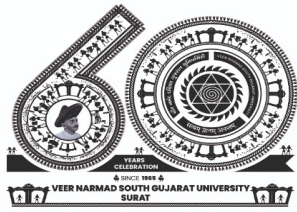
- i) A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- ii) A Master's Degree with at least 55% marks (or an equivalent grade on a point scale, wherever the grading system is followed).
- iii) A minimum of eight years of experience in teaching and/or research in an academic/research position equivalent to that of an Assistant Professor in a University, College, or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy-five (75) as per the criteria given in Appendix II, Table 2

1. The Last Date for receipt of Applications is **30/04/2025 till 06.00 P.M.**
2. Applications received after the last date and time mentioned above will be rejected.
3. Candidate should download the respective Application form from [www.vnsgu.ac.in](http://www.vnsgu.ac.in) and fill the entire application form through computer typing only.
4. **The Candidates are informed to assign Page Numbers sequentially to all self-attested additional documents attached after the Application Form. Moreover, the Applicant needs to mention relevant Page Numbers in the prescribed Application Form wherever asked for.**
5. The regulations/norms and other service conditions prescribed in the present advertisement are as per the Notification **UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018 (18th July, 2018), ALL INDIA COUNCIL FOR TECHNICAL EDUCATION NOTIFICATION, 2019 (1<sup>st</sup> March, 2019)** and subsequent amendments from time to time till the last date of receiving application.

Applicants must send/submit **Eight (1 Original + 7 Photocopies)** hardcopy of the application in the envelope as per the given proforma in the application form to the office of Registrar, Veer Narmad South Gujarat University, Surat on or before the last date and time of receiving the application along with all Self-Attested testimonials, etc. and with supporting documents relating to his or her Academic/Research Score to substantiate his or her candidature.
10. Applicant should also submit a self-attested photocopy of any Government issued proof of Identity.
11. **Persons with Disability (PwD) are required to submit the relevant Disability Certificate issued by the competent authority as per the policy of the Government of Gujarat.**
12. Applicants are advised to apply to the University well in advance without waiting for the last date and time to avoid any kind of delays due to unforeseen events or circumstances. The University shall not be responsible for any delay at any stage.
13. Experience and qualifications will be reckoned as on the last date and time for submission of application. Any updating of qualifications, credentials, experience, etc. will not be entertained after the last date and time of receiving the application.
14. The applicant must ensure that he/she fulfills the eligibility conditions for the Post applied as per respective Notifications.

15. The candidates applying for the Posts of Associate Professor/Assistant Professor must enter the relevant Academic/Research Score (A/R Score) in the space provided against the given categories in each of the Column and it must be supported by documentary evidence, without which no claim on account of Academic/Research Score would be entertained.
16. In no circumstances any content of the application form should be modified.
17. As per the requirement of the candidate, in the given Templates only ROWs can be added/deleted. In any circumstances, no COLUMN can be added to the prescribed Template in the application form.
18. Candidates applying for the Posts of Associate Professor shall necessarily submit Self-Attested FOUR Copies of the Best Ten and Seven Full-length Research Papers respectively, along with their application in the given separate proforma.
19. **For Item No. 14.1 to 14.6 in application form and Best Research Publications, the candidate should strictly adhere the “Clarifications for Table-2” while filling up the application form.**
20. For Research Papers published before 14<sup>th</sup> June 2019, Self-attested proof of peer-reviewed Journal or UGC listed Journal on the date of publication should be provided. Also for Research Paper published on or after 14<sup>th</sup> June 2019, Self-attested proof of Journal listed in UGC-CARE on the date of publication should be provided.
21. In case of consultancy, supportive documents as applicable such as nature of consultancy, role and responsibility of the applicant pertaining to said consultancy, revenue sharing document, copy of MOU and any other relevant document.
22. The candidate who desires to apply for more than one teaching post will be required to submit a separate application in the prescribed format along with all the supporting documents and an additional application fee along with each application.
23. Applicants awarded degrees (apart from Doctorate Degrees) by Foreign Universities shall be required to submit an Equivalence Certificate issued by the Association of Indian Universities, New Delhi. The University reserves the right to demand an Equivalence Certificate for various degrees from any of the applicants.
24. **Reservation for Persons with Disabilities will be as per the existing policy of Government of Gujarat.**
25. No TA/DA shall be paid to the candidates for attending Personal Interviews.
