Filling up of one (1) vacancy in the grade of Staff Car Driver (Ordinary Grade) in Level-2 (Rs. 19900-63200-I) as per 7th CPC in the Department of Commerce on Deputation cum Absorption basis.

Classification of Post	General Central Service, Group C, Non-Gazetted, Non-Ministerial
Level in Pay Matrix	Level-2 in the Pay Matrix (as per 7th CPC, Rs 19900-63200)
Method of recruitment	Deputation cum Absorption basis (For Armed Forces Personnel : Deputation/re-employment)
Period of deputation	The period of deputation, including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization / Department of the Central Government shall ordinarily not exceed 3 years.
Age Limit	The maximum age limit for appointment on deputation shall be 56 years as on closing date of receipt of applications.
Eligibility Conditions	Officials holding the post of Dispatch Rider on regular basis or regular Group C employees in Level-1 of the pay matrix (Rs. 18000-56200) in Ministries of the Central Government who fulfil the necessary educational and other qualifications. The candidate should possess a valid Driving License for Motor Cars and shall have to take a Driving Test (will be conducted by this Department) to assess the competence of the applicants to drive Motor Cars.
Educational and other qualifications required	<b>Essential:</b> (i) Possession of a valid driving license for motor cars. (ii) Knowledge of motor mechanism (The candidate should be able to remove minor defects in vehicle) (iii) Experience of driving a motor car for at least three years. (iv) Have passed 10th standard from recognized Board. <b>Desirable:</b> Three years' service as Home Guard/ Civil Volunteer. <b>Note -</b> The qualification regarding experience is relaxable at the discretion of the competent authority.
