### VACANCY CIRCULAR

Subject: Filling up two posts of Assistant Halwai-cum-Cook in the Department of Food & PD on deputation/absorption basis in Level-2 of the pay Matrix- Regarding.

The undersigned is directed to state that two posts of Assistant Halwai-cum-Cook in the Department of Food & Public Distribution is to be filled up on deputation/absorption basis. The post belong to General Central Service Group 'C' (Non-gazetted & Non-Ministerial) and carries pay at Level-2 in the Pay Matrix.

- 2. The post will be filled up on deputation/absorption amongst the officials of the Central Government-
- (i) holding analogous posts on regular basis; or
- (ii) Canteen Attendant in Level 1 in the pay matrix with at least three years regular service having one year experience as helper to Halwai-cum-Cook; and
- (iii) possessing diploma or certificate in catering.
- 3. The educational & other essential and desirable qualifications needed are as under:
- (i) Class 10th Pass with a diploma or certificate in catering;
- (ii) one year experience in the field;
- (iii) a Trade skill test for cooking including maintenance of hygiene etc, shall be conducted to assess suitability of the Candidate.
- 4. The Departmental official in the feeder category who are in the direct line of promotion shall be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- 5. The period of deputation, including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years. The Maximum age limit for appointment by deputation is 56 years as on the closing date of the receipt of application.
