It is proposed to fill up 1 (one) post of Staff Car Driver (Ordinary Grade) under ST (Scheduled Tribe) category in Central Administrative Tribunal, Mumbai Bench, Mumbai on regular basis in Level-2 in the revised pay matrix, corresponding to the Prerevised pay in Pay-Band-1 (Rs. 5200 - 20200) with Grade Pay of Rs. 1900/-.

The following are the conditions stipulated for the post of Staff Car Driver:

Sr. No.	Particulars	Essentials/Requirement
1.	Age Limit:	18-27 Years; {relaxable in case of employees of Central Government or State Government or State or Supreme Court or High Court and the District Court including the employees of the Central Administrative Tribunal upto age of 40 years}
2.	Educational Qualifications:	Pass in Matriculation or equivalent.
3,	Essential:	Possessing a valid Driving License for LMV; Basic knowledge of Motor Mechanism; Experience of driving LMV for atleast three years.
4.	Desirable	Three years as Head Guard or Civil Volunteers.
5.	Place of Posting	Mumbai. However, the post of Staff Car Driver carries the liability of All India transfer.
6.	Place of Examination	Mumbai,
7.	Mode of Examination	(i) Preliminary Test/Objective Type (Written) Test will be conducted in General Maths, General Knowledge, Current Affairs, Logical Reasoning, Driving Symbols and Simple RTA Rules for 100 marks. (ii) The candidate(s), who secures 60% and above in preliminary test/written test shall be called for Trade Test/Driving Test. (iii) The final merit list will be prepared in respect of the qualified candidates by giving 40% weightage to the marks obtained in the preliminnary test/written test and 60% weightage to the marks obtained in the Trade Test/Driving Test.

The number of vacancies are subject to variation at the discretion of the competent authority.
