7. Required **Odia Test Pass Certificate** issued within 16.03.2024. ✓
8. **Caste Certificate by birth** in Support of claim as SCs/ STs/S.E.B.Cs (Please see and refer Note- 2 of the Advertisement) issued within 16.03.2024. ✓
9. **Recent SEBC Certificate** (issued within **17.03.2021 to 16.03.2024**), wherever applicable. ✓
10. **Permanent Disability Certificate** indicating percentage of disability (i.e., **40% and more**) issued within 16.03.2024. ✓
