Sub: Advertisement for appointment/engagement of Special Public Prosecutor (Retainer Counsel) for CBI.

Applications are invited (in prescribed proforma) from eligible Advocates for appointment/engagement of one Special Public Prosecutor (Retainer Counsel) for handling appeals/revisions/petitions in respect of CBI cases before the Hon'ble High Court of Gujarat at Ahmedabad.

Fee Structure in respect of CBI Special Public Prosecutor (Retainer Counsel):

Counsel fee / Professional fee of the Advocates engaged as Special Public Prosecutor (Retainer Counsel) will be governed by the terms and conditions contained in the DOPT letter No. 225/18/2023-AVD-II dated 24th January, 2024 and various instructions / circulars issued by the Govt. of India as well as CBI in this regard.

Eligibility Criteria:

Eligibility criteria for applying for the post of Special Public Prosecutor (Retainer Counsel) for CBI are as under:

- 1. Educational Qualification: LLB from any recognized university in India.
- 2. Registration as an Advocate with the Bar Council.
- 3. Experience of 10 years or more in handling criminal matters as an Advocate.
- 4. Maximum age as on last date of submission shall not be more than 62 years.
- 5. No criminal case shall be pending against him/her.
- 6. An unconditional willingness/consent to work on the general terms and conditions approved by the Government of India from time to time.

<u>Period of Appointment/Engagement</u>: Appointment/engagement of Special Public Prosecutor (Retainer Counsel) for CBI will be for a period of 03 years, subject to review of performance at the end of every year.

<u>Nature of Job:</u> To represent the CBI before the Hon'ble High Court of Gujarat in various matters assigned by the CBI.

Documents required to be submitted along with the application:-

- 1. Date of Birth certificate (Matriculation certificate).
- Educational Qualification certificate(s).
- Enrolment Certificate as an Advocate with the Bar Council.
- Experience at Bar for 10 years or more in handling criminal matters as an Advocate.
- An unconditional willingness/consent to work on the general terms and conditions approved by the Government of India from time to time.
- 6. An undertaking that no criminal case is pending against him/her.
- 7. Details of important cases handled by the applicant Advocate.

The complete application in the prescribed proforma along with the requisite documents must be submitted through online mode as link given on CBI website. Applications submitted after last date, in offline mode and/or incomplete in any respect shall be liable to be rejected.

Shortlisted candidates shall have to bring all the uploaded and supporting documents, in original, during the interaction with the Interaction Committee. This office reserves the right to accept or reject any application without assigning or communicating any reason thereof and to take any decision including the cancellation of the advertisement.

Last date of submission of online application is 07.07.2025 (15.00 PM).
