2. <u>CONTRACT PERIOD, AMOUNT AND OTHER TRAVELLING EXPENSES</u>:

The candidate shall be appointed on Contract basis for a period of one year. Renewal may be possible at Bank's sole discretion in terms of extant policies and rules.

3. <u>CONTRACT AMOUNT AND OTHER TRAVELLING EXPENSES</u>:

The contract amount shall be paid an amount equivalent to last pay & allowances drawn less the initial amount of Pension fixed before commutation plus relief etc. payable thereon or Rs. **25,000/- p.m.** whichever is lower. Further a lump sum amount of Rs. 1000/- p.m. shall be paid towards Mobile, Conveyance etc. However, the condition of "Last Pay & Allowance drawn by the Officer less the initial amount of pension fixed before commutation plus relief etc." will be applicable only to the pension co-opted retired bank official of a Nationalized Bank and in case of non-pensioner, the candidate will be eligible only for Rs. 25,000/- p.m. together with lump sum amount of Rs.1000/- towards Mobile, Conveyance etc. Please note that no other benefits or charges shall accrue or be payable.

4. <u>LEAVE</u>:
