4.	Age Limit	Maximum age limit will be 65 years as on 31.01.2025.
5.	Essential Experience	Minimum 25 Years work experience in any Govt. and Mining Department/Central PSU/State PSU. Out of this, the candidate must have served at least 10 years in a Class-I or higher rank position. Preference will be given to candidates with significant experience in coal exploration, allotment processes, mine operations, coal quality/Grade Control, resource, estimation, and regulatory compliance.
