The Central University of Kerala invites applications from eligible candidates to be engaged as **Consultant in Physical Education** for a period of 179 days on contractual basis.

Job profile: -

Supervision and co-ordination of the **Physical education** programs and needs of the students of Central University of Kerala. The Consultant has to train the students, encourage and accompany them to participate in the Interuniversity and National level competitions.

1. Qualification, Knowledge and Skills required: -

Essential

- M.P.Ed in Physical Education (Master of Physical Education) from a recognized university with not less than 55% of Marks or its equivalent grade in point scale where grading system followed.
- Ten years of experience either in University Assistant DPES/College DPES.
- Evidence of having produced good performance teams/athletes for competition like State/National/Inter-University/Combined University etc.

Desirable

- The candidate should have knowledge in Computer Applications.
- Ph.D in Physical Education

2. Remuneration

Consolidated remuneration –Rs.50,000/- per month

3. Age

The age of the Candidate shall not be more than 60 years and retired teachers can also apply.

4. Allowances

Consultant in Physical Education shall not be entitled to any kind of allowance or accommodation, medical reimbursement etc.

5. Drawal of Pension

A retired Government official appointed as consultant shall continue to draw pension and the dearness relief on pension during the period of his/her engagement as Consultant. His/her engagement Consultant shall not be considered as re-employment.

6. TA/DA

No TA/DA shall be admissible for joining the assignment or on its completion.

7. Tenure

The engagement is purely temporary and is for a period of 179 days w.e.f the date of joining or till further orders. The engagement shall be extendable for further period if the service of the incumbent is found suitable and as per the requirement/sanction of the authority. He/she shall not have any claim for future appointment – whether permanent or any other type – merely on the basis of this engagement. The engagement will be automatically terminated on expiry of the initial period of engagement.

8. Leave

The Consultant in Physical Education shall be eligible for one-day leave in a completed calendar month. No remuneration for the period of absence in excess of the admissible leave will be paid to the consultant. Also, un-availed leave shall neither can be carried forward nor encashed. The Competent Authority would be free to terminate the service of trainer in case of absence of more than 15 days beyond the entitled leave in a calendar year.

9. Tax deduction at Source

TDS as admissible shall be deducted from the monthly remuneration of Sports Trainer.

10. Working hours

Usual working hours of the University.

1. The selection will be through interview.
