6. **Odia Test Pass Certificate.**
7. **Caste Certificate by Birth** in support of claim as SC/ST/SEBC issued by the Competent Authority within the closing date of Online Application. SEBC Certificate must be issued within the last three years from the closing date for submission of Online Application Form.

8. **Sports Certificate** issued by Director of Sports, Odisha, if any. ✓
9. **Permanent Disability Certificate** (including Percentage of Disability i.e. 40% or more) issued by the concerned Medical Board, wherever applicable. ✓
