Subject: Advertisement for the post of full-time Teaching Faculty of Practice (on contract) and Senior Residents in Dr. B C Roy Multi Speciality Medical Research Centre, IIT Kharagpur.

Indian Institute of Technology Kharagpur is an Institute of Eminence, the first and largest in the IIT chain. The Institute, in its maiden attempt in medical education, is in the process of establishing a research driven medical college, Dr. B. C. Roy Multi-Speciality Medical Research Centre and a hospital, Dr. Syama Prasad Mookerjee Superspeciality Hospital within its campus at Kharagpur. The upcoming medical college will be equipped with state-of-the-art teaching and research facilities embedding world standard technologies and IT connectivity in providing a stimulating academic environment for faculty members willing to stretch their clinical boundaries. Primary objective of this endeavour is to run Undergraduate (MBBS) and postgraduate programs (MD, MS) and to nurture world class translational medical research in a multi-disciplinary environment in collaboration with allied academic units of IIT Kharagpur. The hospital in the first phase has started out-patient service, and the in- patient services with critical care and operation theatre will be functional in second phase.

The Institute invites online applications from Indian nationals, Persons of Indian Origin (PIO) and Overseas Citizens of India (OCI), possessing excellent academic qualifications, commitment to top quality teaching and patient care services, having proven credentials for carrying out research and development for the following specializations in the newly set up Dr. B. C. Roy Multi-Speciality Medical Research Centre and Dr. Syama Prasad Mookerjee Superspeciality Hospital.

- 1. **Posts:** (i) Professor of Practice, (ii) Associate Professor of Practice, (iii) Assistant Professor of Practice and (iv) Senior Residents
- 2. **Specialization/Discipline**: Anesthesia, Dermatology, Ophthalmology, Otorhinolaryngology, General surgery, Gynae & Obstetrics, General Medicine, Microbiology, Orthopedics, Pediatrics, Psychiatry, Radiodiagnosis.
- 3. **Duty**: Academic, teaching and research involvement in Dr. B. C. Roy Multi-Speciality Medical Research Centre. Hospital and patient care services at Dr. Syama Prasad Mookerjee Superspeciality Hospital.
- 4. Consolidated Remuneration including NPA:
 - i. Professor of Practice: Rs.1,90,000 2,10,000 per month (based on experience).

5. **Duration of appointment**:

- a) **For Faculty position**: The appointment is for one year on a contract extendable for a period of up to 5 years or up to 70 years of age (whichever is earlier) on a yearly renewal basis.
- b) **For Senior Residents**: The upper age-limit for appointment as a Senior Resident in broad specialties shall be forty-five years, provided that for the subjects of Anatomy, Biochemistry, Physiology, Pharmacology, Microbiology, Pathology, Forensic Medicine and Community Medicine, the upper age-limit shall be fifty years. The post of Senior Resident shall be for a maximum period of three years on yearly renewal based on performance.
- 6. **Experience:** Research and other requirements for faculty in medical and surgical broad specialties (Eligibility as per National Medical Commission; reference and details as given below): Doctor of Medicine (M.D) / Master of Surgery (M.S)- as the case may be.

- 8. **Medical facility:** Medical facility (limited to OPD services) for self and other dependent family members in the Dr. B. C. Roy Technology Hospital within the campus.
- 9. **Leave:** Applicable as per existing institute norms for employees on contract.

ELIGIBILITY CRITERIA

Posts	Teaching experience, research, and other requirements
1. Professor of Practice (Academic qualifications as per Table A and Table B)	(a) (i) Associate Professor in the subject for three years in a recognised medical institution; or (ii) Specialist Medical Officer of the Armed Forces having at least three years of experience as Associate Professor in the relevant speciality in a teaching hospital of the Armed Forces; and (b) (i) have published at least two research publications after becoming Associate Professor and must be amongst the first three authors; have completed the Basic Course in Biomedical Research from a recognised medical institution; and shall be required to undergo Basic Course in Medical Education provided their broad specialty subject is covered under undergraduate training. Note 1: In the case of Aviation Medicine and Marine Medicine, two years of experience as Flying Squadron for Aviation and two years of experience in a Diving and Escape Training School for Marine medicine, shall be considered equivalent to one-year teaching experience as Associate Professor. Note 2: A Senior Consultant, having three years of experience as post graduate teacher of broad specialty or super specialty subject in the National Board of Examination in Medical Sciences recognised Government medical institute shall be eligible to become Professor in a recognised medical institution of the concerned specialty and total number of years of experience as Post Graduate teacher in National Board of Examination in Medical Sciences recognised government medical institute shall be considered as experience as Professor in a recognised medical institute shall be considered as experience as Professor in a recognised medical institute.
2. Associate Professor of Practice (Academic qualifications as per Table A and Table B)	(a) (i) Assistant Professor in the subject for four years in a recognised medical institution or for five years for those appointed directly as Assistant Professor in Government medical institution; or (ii) a Specialist Medical Officer of the Armed Forces, having at least five years of clinical experience in the relevant specialty after obtaining the recognised Postgraduate qualification in the subject, of which at least three years teaching experience as Assistant Professor in a teaching hospital of the Armed Forces; and (b) (i) have published at least two research publications after becoming Assistant Professor and must be amongst first three authors; have completed the Basic Course in Biomedical Research from a recognised medical institution designated by the Commission; and shall be required to undergo Basic Course in Medical Education provided their broad specialty subject is covered under undergraduate training. Note 1: In the specialty of Aviation Medicine and Marine Medicine, maximum of four years' experience in Flying Squadrons and in Diving and Escape training Schools, respectively, will be considered equivalent to two years of teaching experience for becoming Associate Professor. Note 2: A non-teaching Consultant or Specialist or Medical Officer, possessing postgraduate medical degree with ten years of experience in at least 220 bedded Government hospital shall be eligible to become Associate Professor of that broad specialty and on such appointment, shall be required to undergo Basic Course in Medical Education and Basic Course in Biomedical Research within two years of the appointment.

3. Assistant Professor of Practice

(Academic qualifications as per Table A and Table B) (a) one year as Senior Resident in the concerned subject as specified in regulation 8 in a recognised medical institution.

Note 1: The requirement of one-year Senior Resident experience is relaxed for those appointed directly as Assistant Professor in Government medical institute immediately before the publication of these regulations.

Note 2: The experience gained by a Tutor in a medical institution of his specialty, having a postgraduate degree, shall be considered equivalent to the experience required as a Senior Resident for the purpose of eligibility for the post of Assistant Professor.

Note 3: The experience gained by

- (a) Demonstrator in a medical institution of his specialty, having a Master of Science and Doctor of Philosophy degree, shall be considered equivalent to the experience required as a Senior Resident for the purpose of eligibility for the post of Assistant Professor; or
- (b) Specialist Medical Officers of the Armed Forces having at least one year teaching experience or two years of clinical experience after obtaining the requisite postgraduate qualification in the concerned subject.

Note: In the specialty of Aviation Medicine and Marine Medicine two years of such experience in flying Squadrons and in Diving and Escape training Schools respectively will be considered equivalent to one year of teaching experience (in lieu of Senior Resident) to become an Assistant Professor; or

- (c) a non-teaching Consultant or Specialist or Medical Officer, possessing postgraduate medical degree with at least two years of experience in a Government hospital having at least 220 beds shall be eligible to become an Assistant Professor of that broad specialty without the requirement of experience as Senior Resident and shall complete the Basic Course in Biomedical Research within two years of appointment; or
- (d) diploma holders appointed as Senior Residents in a recognised medical institution before 08.06.2017 having total experience of four years as Senior Resident; or
- (e) diploma holders working as Specialist or Medical Officer in the respective departments of a government medical institution or Government medical institution running National Board of Examination and Medical Science recognised teaching programme having cumulative experience of six years.

4. Senior Resident

- (a) Postgraduate degree in Doctor of Medicine or Master of Surgery or Diplomate of National Board **or**
- (b) Postgraduate medical degree in Master of Science with Doctor of Philosophy in the medical subjects of Anatomy or Biochemistry or Physiology or Pharmacology or Microbiology, shall be eligible for appointment as a Senior Resident.

Note: For the purposes of appointment as faculty in Emergency Medicine department, the previous teaching experience in the broad specialties of General Surgery/Anesthesia/Respiratory Medicine/Orthopedics/General (or internal) Medicine shall be counted and on such appointment, shall complete faculty development programme or trainings prescribed by the Commission, within two years of appointment.

NATIONAL MEDICAL COMMISSION NOTIFICATION

New Delhi, the 30th June 2025.

F. No.N-P051(12)/18/2024-PGMEB-NMC. – Whereas, the Teachers Eligibility Qualifications in Medical Institutions Regulations, 2025 were notified in the website of the National Medical Commission on 17th January, 2025 inviting suggestions and objections from all persons likely to be affected thereby, within thirty days from the date on which the copy of the said regulations were made available to the public;

And whereas, the objections and suggestions received from the public on the said regulations within the period so specified, have been considered by the Commission.

Now, therefore, in exercise of the powers conferred by clause (e), (s) and (x) of sub-section (2) of section 57 of the National Medical Commission Act, 2019 (30 of 2019) read with clauses (b) and (c) of sub-section (l) of section 10, clause (f) of sub-section (l) of section 24 and clause (e) of sub-section (1) of section 25 of the said Act and in supersession of the Teachers Eligibility. Qualifications in Medical Institutions Regulations, 2022, except as respects things done or omitted to be done before such supersession, the National Medical Commission hereby makes the following regulations, namely: __

- **1. Short title and commencement.** (1) These regulations may be called the Medical Institutions (Qualifications of Faculty) Regulations, 2025.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Definitions.** (1) In these regulations, unless the context otherwise requires, _
 - (a) "Act" means the National Medical Commission Act, 2019 (30 of 2019);
 - (b) "administrative posts" means the posts of Medical Superintendent or Dean or Director or Principal of a medical institution;
 - (c) "broad specialty" means the specialties in Master of Surgery or Doctor of Medicine or Diploma specified in Table A and Table B of the Schedule;
 - (d) "Commission" means the National Medical Commission;
 - (e) "faculty" includes, -
 - (i) "medical faculty" consisting of Professor or Associate Professor or Assistant Professor having Bachelor of Medicine and Bachelor of Surgery degree and higher qualifications as specified in tables A, B, C and D of the Schedule;
 - (ii) "non-medical faculty" consisting of Professor or Associate Professor or Assistant Professor having Master of Science with Doctor of Philosophy qualifications as specified in regulation 11; and
 - (iii) "dental faculty" consisting of Professor or Associate Professor or Assistant Professor having Bachelor of Dental Surgery and higher qualifications as specified in regulation 20.
 - (f) "institute of national importance" means any of the institutions specified in the Schedule to the Act other than institutes granting qualifications of National Board of Examination;
 - (g) "medical institution" means any institution within or outside India which grants degrees, diplomas or licences in medicine and includes affiliated colleges and deemed to be Universities;
 - (h) "transition period" means such period as may be determined by the Commission based on the recommendations of the Postgraduate Medical Education Board for the purposes of allowing alternate qualifications for eligibility of faculty in a broad or super specialty, till adequate faculty with qualifications specified for such specialty are available;
 - (i) "recognised medical institution" means any institution recognised by the Commission;
 - (j) research publication" means only original papers, meta-analysis, systematic reviews, and case series that are published in journals indexed in Medline, PubMed Central, Science Citation Index, Citation Index,

Expanded Embase, Scopus or Directory of Open Access Journals and other such journals as may be specified by the Commission from time to time;

- (k) "Schedule" means the Schedule annexed to these regulations;
- (1) "super specialty" means specialties specified in Table C and Table D of the Schedule.
- (2) The words and expressions used herein but not defined and defined in the Act, shall have the meanings assigned to them in the Act.
- 3. Qualifications for medical and non-medical faculty. (1) The academic qualifications required for medical and non-medical faculty in a medical institution.
 - (a) in any of the medical broad specialties shall be as specified in Table A of the Schedule;
 - (b) in any of the surgical broad specialties shall be as specified in Table B of the Schedule;
 - (c) in any of the medical super specialties shall be as specified in Table C of the Schedule;
 - (d) in any of the surgical super specialties shall be as specified in Table D. of the Schedule.
- (2) The qualifications relating to, experience, research and other requirements for medical and non-medical faculty in a medical institution,
 - (a) in the medical broad specialties and surgical broad specialties shall be as specified in Table E of the Schedule;
 - (b) in the medical super specialties and surgical super specialties shall be as specified in Table F of the Schedule.
- 4. Age-limit of faculty. No person shall serve as a faculty beyond the age of seventy years.
- 5. Qualifications for administrative post of Dean or Director or Principal or Medical Superintendent of a recognised medical institution. (l) A medical faculty shall be eligible for appointment to administrative posts in a medical institution if he possesses at least ten years of teaching experience in a medical institution, of which at least five years shall be as a Professor.
- (2) Appointments to any of the administrative posts shall be made on the basis of seniority-cum-merit.
- (3) A member of the medical faculty holding administrative post shall not be eligible to hold the position of Head of the Department.
- 6. Qualifications of Head of Department. A member of medical faculty possessing the qualifications mentioned in Tables A, B, C and D of the Schedule shall be eligible for the post of the Head of Department in the concerned specialty.
- 7. Determination of equivalent qualifications of Diplomate of National Board. (1) The Diplomate of National Board qualification in broad specialty and super specialty shall be considered equivalent to the corresponding broad specialties and super specialties academic qualifications specified in Table A, Table B, Table C and Table D of the Schedule, when awarded by the National Board of Examinations after training in a medical institution with an attached hospital or in a hospital having a bed strength of 500 or more.
- (2) For the purposes of equivalence in teaching, persons holding a Diplomate of National Board qualification in broad specialty obtained from medical institutions with a bed strength of less than 500 shall be required to complete an additional one-year senior residency in a recognised medical institution in the relevant specialty.
- 8. Senior Resident. (l) Any person undergoing residency in a relevant department of a recognised medical institution after obtaining the following qualification, namely:
 - (a) postgraduate degree in Doctor of Medicine or Master of Surgery or Diplomate of National Board; or
- (b) postgraduate medical degree in Master of Science with Doctor of Philosophy in the medical subjects of Anatomy or Biochemistry or Physiology or Pharmacology or Microbiology, shall be eligible for appointment as a Senior Resident.
- (2) The upper age-limit for appointment as a Senior Resident in broad specialties shall be forty-five years:

Provided that for the subjects of Anatomy, Biochemistry, Physiology, Pharmacology, Microbiology, Pathology, Forensic Medicine and Community Medicine, the upper age-limit shall be fifty years.

- (3) The post of Senior Resident shall be for a maximum period of three years.
- (4) Any person pursuing postgraduate super specialty courses shall also be designated as Senior Resident.
- (5) The experience gained by a Senior Resident having a postgraduate degree and working in a super specialty department offering super specialty teaching shall be valid for appointment as Assistant Professor, provided that such Senior Resident's broad specialty qualification is a feeder qualification for the relevant super specialty.
- 9. Tutor. Any person possessing a Bachelor of Medicine and Bachelor of Surgery degree shall be qualified for appointment as a Tutor.
- 10. Demonstrator. Any person, possessing a Master of Science degree in a medical subject and Doctor of Philosophy degree on the same subject, shall be qualified for appointment as a Demonstrator if such qualification is obtained through a regular, in campus course from a recognised medical institution.
- 11. Appointment of non-medical faculty. Any person possessing the academic qualfications specified in column (3) of the table below, in the corresponding specialties specified in column (2) of the said table, shall be eligible for appointment as a non-medical faculty as per the minimum standards requirement specified by the Commission from time to time, if such qualification is obtained through a regular, incampus course from a recognised medical institution, namely: —

12. Appointment of faculty during transition period. — Where there is a shortage of qualified faculty in a particular specialty, any person possessing the qualifications specified in Tables A, B, C and D of

the Schedule shall be eligible for appointment as faculty in that specialty, for the transition period, and having any of the following experience, namely:—

- (a) at least three years of experience in a medical institution with an exclusive department or unit dedicated to the specialty, having separate and dedicated infrastructure and faculty members who are not concurrently shown as part of any other department or unit; or
- (b) at least three years of experience in an institute of national importance with a dedicated department or unit in the specified specialty; or
- (c) at least three years of experience in a reputed or recognised institute of excellence in India or abroad, approved by the Commission, running a department or unit dedicated to the specified specialty; and
- (d) shall have at least two research publications in the concerned specialty during the three years period specified above and must be amongst first three authors.
- 13. Counting of teaching experience in certain postings. A cumulative period of up to five years served by a faculty member in the Commission or a University or State Medical Council or medical education department or medical research related Government organisation, shall be deemed teaching experience and be included in the computation of total service period of the faculty member.
- **14. Exemption from Basic Course in Medical Education.** The following faculty shall be exempt from the requirement to undergo the Basic Course in Medical Education, namely:
 - (a) any faculty serving in super specialty departments or in broad specialty subjects not included in the undergraduate curriculum; and
 - (b) any faculty serving in an institute of national importance:

Provided that the faculty specified in clause (b) shall be required to complete the course within two years of appointment in a recognised medical institution.

- 15. Appointment of Assistant Professors of Statistics. Any person who possesses the following qualifications shall be eligible for appointment as Assistant Professor of Statistics in the Department of Community Medicine namely: ...
 - (a) a Master of Science degree in Health Statistics or Medical Statistics or Biostatistics or Statistics; and
 - (b) a Doctor of Philosophy degree.
- 16. Eligibility for designation as Postgraduate Guide in broad specialties. A faculty member in a medical institution shall be eligible to be designated as a Postgraduate Guide in a broad specialty if such member possesses at least five years of teaching experience in the respective specialty as an Assistant Professor or above.
- 17. Eligibility for designation as Postgraduate Guide in super specialties. A faculty member in a medical institution shall be eligible to be designated as a Postgraduate Guide in a super specialty if such member possesses at least three years of teaching experience in the respective super specialty as an Assistant Professor or above.
- 18. Equivalent foreign postgraduate qualifications.  - (i) such person has completed the supervised training programme culminating in the Fellow of the Royal College of Surgeons or Fellow of the Royal College of Physicians of the respective specialty; and
 - (ii) for super specialties, has at atleast two years of supervised sub specialty Fellowship programme in the respective sub specialty.
