The candidates not appearing in the Test shall stand disqualified.

Instructions to the Candidates for the Endurance (Walking) Test:

1. The candidates should report at the venue (RPRC, Bhubaneswar) as per the schedule.
2. The candidate will produce the following documents:
 - a) Production of self-downloaded and self-attested copy of Intimation Letter issued by OPSC.
 - b) Original Identity proof such as Aadhaar/PAN Card/Voter Card/Passport/Driving License.
 - c) **UNDERTAKING** supported by a **Certificate from a Registered Medical Practitioner/Physicians that "HIS/HER BLOOD PRESSURE IS NORMAL"**.
3. Only one person (parent/guardian/relatives) will be allowed with the candidate during the Test when preferred by the candidate.
4. This test is being re-conducted in pursuance to the Orders dated 18.08.2025 of Hon'ble High Court in W. P. (C) No. 20102 of 2025 and similar batches of cases.
