1. Hard Copy of Online Application form mentioning **Roll No** at the **Top Right-hand Corner**.
(Online Applications are available in the website of the Commission. The candidates are required to download the same using their respective e-mail ID/Phone Number and Password/ OTP etc through OPSC e-Chayan Portal via www.opscechayan.in)
2. **H.S.C. or Equivalent** Certificate in support of declaration of age.
3. **Intermediate/ +2 Examination** Certificate issued by the Concerned Board/Council.
4. **Bachelor's Degree** Certificate.
5. **Mark Sheets** in support of all the Examinations (H.S.C to Degree) including fail marks, if any, issued by the concerned Board/Council/University.
6. **Three (03)** passport size photographs (Unsigned & Unattested) which has been uploaded with application form.

7. **Caste Certificate by birth** in support of claim as **SEBC/ST/SC** whichever applicable. SEBC Certificate must be issued within the last three years from the closing date for submission of the Online Application Form. (which has been uploaded with online Application Form)
8. Required **Odia Test Pass** Certificate as per Para-10(ii) of the Advertisement, wherever applicable.
9. **Permanent Disability** Certificate (indicating Percentage of Permanent Disability i.e. **40% and more**), wherever applicable.
10. Discharge Certificate of **Ex-Servicemen** issued by the Commanding Officer of the Unit last served. Ex-Servicemen candidates must submit an Affidavit undertaking that he/she has not been appointed against any 'civil post' after retirement from 'military service', wherever applicable.
11. Identity Card of **Sports Persons** issued by the Director of Sports Odisha, wherever applicable.
