NOTE: The reservation for PwBD as indicated for the Discipline of Graduate Apprentice, Trade Apprentice Data Entry Operator (Fresher & Skill Certificate Holders) shall be applied on horizontal basis, across all categories, as per the Government guidelines. PwBD are not eligible to apply for Discipline Code 101, 102, 103, 104, 105, 106, 107, 108, 109, 110, 111. A person with specified disability listed in the Schedule appended to the Act but not covered under Section 34(1), if certified by the certifying Officer as a person with disability of 40% or above, shall be allowed concession/relaxation available to PwBD. His/her candidature will not be considered/adjusted against reservation provided to PwBDs under Section 34(1) of the Act of 2016.

For PwBD (Persons with Benchmark Disability) category, Govt. of India Guidelines shall apply.

The Rights of Persons with Disabilities Act 2016 - Section 2(r) defines "person with benchmark disability" as a person duly certified by the certifying authority with

- not less than 40% of a specified disability where specified disability has not been defined in measurable terms and
- a disability where specified disability has been defined in measurable terms.

The candidates are required to submit a Disability Certificate issued by competent authority as per the Rights of Persons with Disabilities Rules, 2017 failing which their candidature as PwBD candidates will not be considered.

Persons with Benchmark Disabilities must be capable of performing the task assigned to them/take instructions using suitable aids and appliances. Engagement of apprentices belonging to PwBD category will be from categories below:

Deployment of PwBD with other disabilities, may put such PwBDs at risk, considering ours being a hazardous industry, hence not included.

STIPEND: Rate of stipend payable to apprentices per month shall be as prescribed under Apprentices Act, 1961/1973, Apprentices Rules 1992/2019 as amended from time to time.

For Graduate and Technician Apprentice, the stipend will be paid in two parts, Rs 4500 for Graduate Apprentice and Rs 4000 for Technician Apprentice will be paid by the Board of Apprenticeship Training (BOAT) directly in their bank accounts and the remaining amount by Indian Oil Corporation Ltd. It is essential that the candidates have an Aadhaar seeded bank account that is enabled for Direct Benefit Transfer (DBT) for receiving the Government's share of stipend from BOAT.

Trade Apprentice would be receiving the stipend in full, from Indian Oil Corporation Limited.

However, the above shall be subject to change as per guidelines and advice from Government/ Board of Apprenticeship Training/ National Apprenticeship Promotion Scheme (NAPS) or any such body stipulated by the Act/ Rules for issuing guidelines regarding Apprenticeship, from time to time.

Prescribed Qualification/Eligibility Criteria:

- For Discipline Code - 101 - Technician Apprentice (Mechanical) -**3 years regular full time Diploma in Mechanical Engineering with minimum 50% marks in aggregate for General, EWS and OBC-NCL & 45% in case of SC/ST/PwBD candidates for reserved positions from a Institute/University recognized by AICTE/UGC.
- For Discipline Code - 102 - Technician Apprentice (Electrical) -**3 years regular full time Diploma in Electrical Engineering with minimum 50% marks in aggregate for General, EWS and OBC-NCL & 45% in case of SC/ST/PwBD candidates for reserved positions from a Institute/University recognized by AICTE/UGC.
- For Discipline Code - 103 - Technician Apprentice (Instrumentation) -**3 years regular full time Diploma in Instrumentation Engineering with minimum 50% marks in aggregate for General, EWS and OBC-NCL & 45% in case of SC/ST/PwBD candidates for reserved positions from a Institute/University recognized by AICTE/UGC.
- For Discipline Code - 104 - Technician Apprentice (Civil) -**3 years regular full time Diploma in Civil Engineering with minimum 50% marks in aggregate for General, EWS and OBC-NCL & 45% in case of SC/ST/PwBD candidates for reserved positions from a Institute/University recognized by AICTE/UGC.
- For Discipline Code - 105 - Technician Apprentice (Electrical & Electronics) -**3 years regular full time Diploma in Electrical & Electronics Engineering with minimum 50% marks in aggregate for General, EWS and OBC-NCL & 45% in case of SC/ST/PwBD candidates for reserved positions from a Institute/University recognized by AICTE/UGC.
- For Discipline Code - 106 - Technician Apprentice (Electronics) -**3 years regular full time Diploma in Electronics Engineering with minimum 50% marks in aggregate for General, EWS and OBC-NCL & 45% in case of SC/ST/PwBD

candidates for reserved positions from a Institute/University recognized by AICTE/UGC.

- For Discipline Code - 112 - Graduate Apprentice (BBA/BA/B. Com/B.Sc.) -**Regular full time Graduate in any discipline with minimum 50% marks in aggregate for General, EWS and OBC-NCL & 45% in case of SC/ST/PwBD candidates for reserved positions from a Institute/University recognized by AICTE/UGC.
- For Discipline Code - 113 - Trade Apprentice-Data Entry Operator (Fresher) -**Class 12th (but below graduate)
- For Discipline Code - 114 - Trade Apprentice-Data Entry Operator (Skilled Certificate Holders) -**Class 12th (but below graduate). Additionally, candidates should possess Skill Certificate of 'Domestic Data Entry Operator' for training of less than one year issued by an awarding body recognized under National Skill Qualifications Framework or any other authority recognized by the Central Government.
- For all discipline codes:** The qualification prescribed shall be from a recognized University/Institute as a full-time regular course in relevant disciplines. Qualification acquired through Part-time / Correspondence / Distance Learning mode shall render the candidate NOT ELIGIBLE for the above notified disciplines.
- Wherever CGPA/OGPA or Letter Grade is awarded in the Class XII/ITI/ Degree/Diploma examinations, its equivalent aggregate percentage of marks must be indicated in the Online Application as per the norms adopted by Board/University/Institute. Candidates will have to furnish certificate from the concerned University/Institute regarding the equivalent aggregate percentage of marks with reference to their CGPA/OGPA or Letter grade at the time of document verification failing which their candidature will not be considered.

- Candidates applying under NAPS who have completed five years as on 30.09.2025 in relevant discipline after acquiring the prescribed qualification as per the last semester/ year marksheet shall NOT BE ELIGIBLE for engagement as apprentices.
- In case the date of Declaration of result is not mentioned in the Mark Sheet, the candidate must submit a certificate mentioning the date of publication of result from the Principal of the Polytechnic/College/Institute from where the candidate pursued his course along with his Application Form.
- Candidates registered with Local/State Employment Exchange(s)/ Vocational Rehabilitation Center for Person with Benchmark Disability (PwBD) and meeting the prescribed eligibility criteria, are required to apply only through NAPS/ NATS portal, failing which their candidature will not be considered.

- Age:** Minimum 18 years and maximum 24 years as on 30.09.2025 (Relaxation of 5 years for SC/ST i.e. up to a max of 29 yrs., 3 years for OBC-NCL i.e. up to a max of 27 yrs., for the posts reserved for them). Candidates belonging to PwBD categories shall be given age relaxation up to 10 years (up to 15 years for SC/ST and up to 13 years for OBC-NCL candidates).
- Period of Apprenticeship Training:** 12 Months
- Selection Methodology:**
 - Candidates registered on NAPS/NATS portal, and applying against the notification shall be considered for selection. **There will be no written Test/ Interview.**
 - Merit list of all the candidates who have applied against a respective post in the portal and meeting the eligibility criteria shall be prepared based on the percentage of marks secured in the prescribed qualification for the post. In case of two candidates securing same percentage of marks, the candidate with earlier date of birth (older in age) shall be considered. In case of same date of birth, candidates having a higher percentage marks in manipulation shall be considered.
 - Candidates are advised to ensure that they are medically fit as per Indian Oil's pre-engagement medical standard. In case any of the above mentioned in 5 (e) and (f) are not linked/ activated, candidate must approach their respective bank's branch for enabling the same.
 - Candidates should submit the details of the active bank account to which their Aadhaar is seeded to the Corporation for release of monthly Stipend.

H. How to Apply

- Candidates meeting the prescribed eligibility criteria may apply online through the NAPS/NATS portal from 12th September 2025 (10:00 AM) to 11th October 2025 (11:55 PM). Candidate to ensure that they have successfully applied for the relevant opportunity through respective NAPS/ NATS portal and thereafter submitted the required information through Microsoft Office Form within the stipulated timeline. **No other mode of applications will be accepted.**
- After applying on the respective NATS/NAPS portal, the candidate MUST also submit their details along with preferred State and three preferred locations in Microsoft Office Form, latest by 11.10.2025, 11:55 PM by visiting the link at <https://forms.office.com/r/DHBa1WFthJ>
Please note that Candidates must submit only one response. Multiple submission of Microsoft Form shall NOT be entertained. It may however be noted that, while location preference shall be considered, the actual posting will be decided based on the requirements of the Corporation; and no further changes shall be entertained.

I. Verification of Documents

Candidates who have applied through NAPS/NATS portal and have been shortlisted on merit will be intimated about document verification on a suitable date at any of our units/ offices or through other modality as decided by the management. The following original documents along with a self-attested copy should be furnished at the time of document verification for joining at Location:

- Mark sheet/Certificate issued by Board of Secondary Education for passing Matriculation(Class X) Examination shall be the only acceptable document in support of age. No other document will be accepted for verification of Date of Birth.
- Latest Caste certificate by reserved category candidates in the Proforma prescribed by the Govt. and issued by Competent Authority only.
- For claiming the benefit of OBC-NCL category, the candidate should submit a latest Caste Certificate (not more than 12 months old from 30.09.2025) in the Proforma prescribed by Govt. of India, which would, among others, specifically mention that the candidate does not belong to the persons/sections (creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel & Training, Government of India OM NO.36012/22/93-Estt.(SCT) dated 08.09.1993. Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits. Accordingly, such candidates may choose to apply for the positions provided they meet the age criteria applicable to UR candidates and indicate their category as "UR". Indian Oil Corporation Ltd. (MD) being a Central Public Sector Undertaking, only those communities that are mentioned in the common list of OBC-NCL approved by Central Government shall be treated as OBC-NCL for the purpose of reservation. Name of OBC caste mentioned in the certificate should fall in the Central List of OBCs of the respective state.
- Certificate from the Institute stating that the Candidate has pursued through regular mode and the year of passing.
- Semester-wise / Year-wise mark sheets of ITI (NCVT/ SCVT) / HSC/ Graduation/ Diploma in Engineering.
- Final ITI (NCVT/ SCVT) Certificate/HSC/Graduation/Diploma in Engineering issued by the respective Board / Authority/ Institute.
- Copy of first page of Bank passbook of Aadhaar seed account, Aadhar card, PAN Card, cancelled cheque leaf.
- Pre-Engagement medical fitness certificate.
