All India Institute of Medical Sciences (AIIMS), Raebareli intends to fill up 10 (Ten) posts of **Junior Residents** purely on ad-hoc basis for a period of 06 months for **All India Institute of Medical Sciences (AIIMS), Rae Bareli (UP)** through walk-in-interview: -

Note:

- I. The reservation for OBC/SC/ST/EWS candidates is as per Central Govt. Rules and 4% for PWD including OPH candidates (on horizontal basis).
- II. In case no applicant is available/turn up for walk-in-interview under EWS Category then the EWS category post shall be filled by UR category. As such UR candidates may also apply for the EWS category.
- III. The above posts are provisional and may be varied as per the discretion of competent authority.
- IV. All the above posts of JRs are on ad-hoc basis till the 06 months form the date of Joining and candidates selected for these posts will be posted at AIIMS, Rae Bareli, Uttar Pradesh.
 - V. In case of a higher number of applicants, a screening test may be held on the same day

ESSENTIAL QUALIFICATIONS:

1. JUNIOR RESIDENTS (Non-Academic):-

- a) The candidates should have passed MBBS (including completion of Internship) or equivalent degree recognized by MCI.
- b) State /MCI Medical registration is mandatory before joining.

Essential qualification for the candidate posted under Hospital Administration Department (Total 03 seats)-

- a) MBBS/BDS from a recognized university/institution.
- b) Must produce experience certificated for actively participated in the application process and successful achievement of NABH Accreditation (As per 5th Edition NABH Standards) in hospital with a total bed strength of more than 300 beds, either in the Government or Private Sector.
- c) Desirable Qualification:

Master of Hospital Administration (MHA) – 2 Years full-time course.

AGE LIMIT: Junior Resident

Upper Age Limit: 37 years, relaxable for Scheduled Caste, Scheduled Tribe candidate up to a maximum period of five (5) years, for OBC candidates up to a maximum period of three (3) years. In case of Physical Handicapped (OPH) candidates, age relaxation up to a maximum period of ten (10) years for General Category, Thirteen (13) years for OBC category and fifteen (15) years for SC/ST category candidates.

PAY SCALES: Junior Resident

In Pay Matrix (Level-10) with a minimum of Rs.56,100/- + NPA (for medical personnel) as per recommendations of the 7th CPC.

TERMS AND CONDITIONS FOR AD-HOC APPOINTMENT IS AS UNDER: -

1. The appointment is purely on ad-hoc basis till the 06 months from the date of Joining. The appointment can also be terminated at any time, from either side without any notice.

- 2. Those who had joined Junior Residency at the AIIMS and whose services were terminated on account of unauthorized absence or any other disciplinary/ground, will be ineligible to be considered for these JR post even if they otherwise qualify.
- 3. For all eligible candidates, maximum three terms*are allowed. AIIMS graduates will be considered to be allotted post on preferential basis. Candidates who have already done 03 terms* of Junior Residency either at AIIMS or outside will not be considered. Experience in Army Services, Central Health Services, Private Nursing Homes and Private Practice will be taken as equivalent to Junior Residency.
 - Note (*): Term of Junior Resident is 06 months, if any one join and leaves at anytime it will be counted as one term irrespective of duration of work. For each term, the candidate (s) required to submit his/her application separately.
- 4. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional remuneration will be admissible in case of such assignment.
- 5. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority/Promotion etc. or any other benefits available to the Government servants, appointed on regular basis.
- 6. All the above posts are meant for All India Institute of Medical Sciences (AIIMS), Raebareli, Uttar Pradesh. Candidate selected for above ad-hoc posts will be posted at AIIMS, Raebareli (UP).
- 7. The appointee shall be a whole-time employee of the Institute and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period.
- 8. The appointment to the said post will be subject to medical fitness from the competent Medical Board for which he/she will be sent to the designated Medical Authority of the Institute.
- 9. Leave entitlement of the appointee shall be governed in terms of instructions contained in DoPT's O.M. No.12016/3/84-Estt. (L) dated the 12th April 1985 as amended by OM No.12016/1/96-Estt(L) dated the 5th July 1990 and OM No.12016/2/99-Estt(L) dated 12 July 1999.
- 10. On appointment, the appointee will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma.
- 11. On appointment, the candidate will not have any claim/right whatsoever for the regular posts in the AIIMS, Raebareli. Further, this cadre will also not be allowed to merge with the cadre in the Institute.
- 12. The appointee is not entitled to any TA/DA for attending the interview and joining the Institute.

- 13. Other conditions of service will be governed by relevant rules and orders issued by Govt. of India from time to time with regard to ad-hoc employees.
- 14. If any declaration given or information furnished by him/her proves false or if he/she is found to have willfully suppressed any material information, he/she will be liable for removal from service and also such other action as the Institute may deem necessary.
- 15. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty members of AIIMS, Rae Bareli (UP).
- 16. Interested candidates may apply for the post under reference in the prescribed application form available at the Institute website appending therewith copies of self-attested certificates/testimonials and other relevant documents in support of their qualification, experience and date of birth etc. and also "No Objection Certificate" from present employer, if working in Govt./Semi Govt./Corporate Body/Undertaking of the Central/State Govt. and in absence of which it may not be possible to allow them to appear for interview. The candidates are also required to produce the original certificates/testimonials at the time of walk-in-interview.

GENERAL INSTRUCTIONS: -

- 1. The candidates must ensure that they fulfil eligibility criteria. If at any stage, it is found that the candidate has furnished any incorrect information his/her candidature will stand cancelled. If any of these shortcoming(s) is/are detected even after the appointment, his/her services will be summarily terminated.
- 2. The candidates should bring their application/bio-data in along with all the documents/certificates in support of their claim and three photocopies of each document including passport size latest photographs.
- 3. All the original certificates/documents will be verified at the time of interview.
- 4. The candidates having prescribed qualification/experience should appear for document verification and interview on **10.11.2025** from 09:30 AM in LT- ground, Medical College, AIIMS, Rae Bareli, Uttar Pradesh.
- 5. The candidates should also bring their original documents/testimonials on the date of interview.
- 6. The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification.
