2. Reservation of vacancies:

- a) SC/ST/OBC [NCL]/EWS : Reservation for SC/ST, EWS, OBC [NCL] & Physically Handicapped candidates shall be as per government guidelines.

3. Eligibility Condition:

- a) Qualification: Minimum prescribed qualification mentioned against each trade.
- b) Age: Minimum 18 years and Maximum 25 years as on 28.02.2026. Relaxation in upper age limits to SC, ST, OBC [NCL] PwBD & others applicable categories shall be as per Government of India guidelines.
- c) Previous Training: Candidates who have already undergone or are currently undergoing Apprenticeship training under Apprentice Act, 1961 in any Govt./Public Sector/Private Industrial organization are NOT eligible to apply for the current enrolment.
4. Payment of Stipend to Apprentices: Rate of stipend payable to apprentices per month shall be as prescribed under Apprentices Act, 1961/1973, Apprentices Rules 1992/2019/2025 as amended from time to time.
5. Selection Procedure: Selection of the candidates will be on merit basis i.e. on the basis of percentage of marks obtained in the respective fields.
6. TA/DA or Accommodation: No TA/DA or accommodation shall be given to the candidate called for verification of certificates or coming to the place of training.

- ii. **Candidate Registration:-** Candidate must click on the Registration Tab for registering themselves for Apprenticeship Training. After registration a confirmation e-mail will be sent to the registered e-mail address of the candidate. The candidate has to click on the link provided in the e-mail for activation (example:- Registration Number-A000000000) and thereafter the candidate has to login and complete his profile for confirmation of registration. The applicant should apply in online mode through official website of apprenticeship portal with the following documents to be uploaded:-

- [a] Matriculation Cert. & All Mark Sheets
- [b] Caste Certificate [for SC/ST/OBC [NCL] only]
- [c] Certificate applicable for EWS candidates
- [d] Medical Certificate applicable for physically handicapped only
- [e] Photo and signature
- [f] Aadhaar Card & Pan Card
- [g] Aadhaar card linked bank account
- [h] Land Acquisition Certificate for Land Displaced Person /Adhaar Card for Project affected family and UCIL ID card of employee for Employee son.

- iii. **Apprenticeship Opportunities:-** After registering online the candidate must click on the Apprenticeship Opportunities Tab section for selecting the desired trade in which Apprenticeship Training is being sought. Thereafter the candidate must also select one or more than one unit i.e. (Uranium Corporation of India Limited, Jaduguda / Narwapahar and Turamdih) in which he/she wishes to undergo Apprenticeship Training on or before 28.02.2026

- iv. Candidate who have applied through online portal from date of this advertisement till date 28.02.2026 shall be considered for further scrutiny. All previous application uploaded prior to this advertisement shall not be considered. They need to apply afresh.

- v. Applications received after the expiry of the due date 28.02.2026 shall not be considered for further scrutiny.

8. **Employment:** As per The Apprentices Act, 1961, it shall NOT be obligatory for UCIL to employ Apprentices on completion of training. There are no provisions for providing direct employment in UCIL on completion of apprenticeship training.

- a) Mere fulfillment of eligibility criteria/norms does not entitle a candidate to be considered for engagement as Apprentice. Management reserves the right to reject the application without assigning any reason and to raise standard of specifications to restrict the number of candidates to be called for engagement as Apprentices. The selection process can be cancelled/suspended/restricted/enlarged/modified without assigning any reasons. The decision of the Management will be final and no appeal will be entertained.
- b) The candidature is liable for rejection at any stage of training process in case of suppression/furnishing of false information.
- c) UCIL can place the candidate for training at any of its unit.
- d) First preference shall be given to candidates belonging to Land Displaced Category, Second preference shall be given to local candidates (within 5 km) radius for project affected family [as per R&R Policy] of all the units of UCIL in Jharkhand region and Third preference shall be given to Employees [who are working in any unit of UCIL] Wards relevant documents shall be verified at the time of joining.
