**B) Duties of Adjunct Faculty :**

- i) Teach Core/ Elective courses in UG and PG in which the person's practical experience and knowledge can add significant value to theory as per the need of academic Departments.
- ii) The Adjunct Faculty will also be associated with the setting of examination papers and the general work of evaluating students' performance in the subject the teaching of which he/she is associated with.
- iii) Supervise student projects and co-supervise research scholars with a view to add practical dimensions to their work.
- iv) The Adjunct Faculty can be a Joint-investigator in sponsored, R&D and consultancy projects, bringing in significant expertise to match industry needs and expectations.
- v) Assist the Department / Institute to break new ground with industry in cutting edge research with a view to develop IP and overcoming technological barriers faced by industry in becoming globally competitive and to be a prime mover in taking the Institute's research based industrial consultancy to new levels in quality and quantity.
- vi) Support Institute development activities with an industry interface, e.g. sponsored & top up programs, Chair Professorships, awards and scholarships, CSR funding, projects etc.
- vii) Adjunct Faculty is also expected to actively participate in service-related activities, such as sitting on department committees, serving as advisors to faculty and/or undergraduate and post graduate students, helping students' network, and providing internship and job opportunities.

**C) Facilities to be Provided :**

Adjunct Faculty would be provided with faculty room and other facilities depending on availability and their involvement in academic activities.

**D) Financial Support :**

Adjunct Faculty shall not be eligible to receive financial support to attend conference in India or Abroad for presenting their work done in the Institute. However, funds from her/his R&D project in the Institute could be utilized for the purpose.

The candidate's contributions to teaching, research and services must be articulated at the time of appointment and the appointee's actual contributions in all three areas must be evaluated at the time of reappointment and advancement.

**E) Remuneration and Facility :**

- i) Adjunct Faculty may be provided travel assistance from her/his Institute to his/her place of stay and back, maximum 6 times per academic year based on requirements and Director's approval.
- ii) No accommodation would be permissible. However, she/he shall be provided free lodging and boarding in the Institute Guest House.
- iii) Adjunct Faculty will be given honorarium payable as per above Table.
