Medical and Health Recruitment Board, Assam invites online application in the website- <https://nhm.assam.gov.in> from the intending candidates having Indian citizenship as mentioned in the Article 5 to 8 of the Constitution of India and having requisite qualification as per norms of National Commission for Indian System of Medicine (NCISM) for recruitment to the vacant post of Principal of Government Ayurvedic College, Guwahati under the Medical Education & Research Department, Government of Assam as indicated below:-

1. **Name of posts:** Principal of Government Ayurvedic College, Guwahati under Medical Education & Research Department.
2. **Number and reservation of posts:** 1 (UR)
3. **Scale of Pay:** Rs.1,44,200.00 – Rs.2,18,200.00/- PM (Special Allowance Rs. 3000/-) Academic level 14 plus other allowances as admissible under Rules.
4. **Age:-** A candidate should not be more than 55 Years as on 01/01/2025, irrespective of category of applicants.
5. **Essential Qualification :**
 - a. 10 (ten) years of teaching experience as regular teacher in the concerned subject or 5 (five) years teaching experience as Associate Professor (Reader) on regular basis in the concerned subject; or 10 (ten) years research experience as full time researcher (after Post Graduate in concerned subject).
 - b. A Post-graduate qualification in Ayurveda from a university recognized by National Commission for Indian System of Medicine (NCISM)/ Central Council of Indian Medicine (CCIM).
 - c. A valid registration with the State Board or Council where the candidate is employed or a valid Central or National Registration Certificate issued by Central Council of Indian Medicine or National Commission for Indian System of Medicine.
 - d. Minimum three research articles published in index journals and one Published book or Manual relevant to Ayurveda, or, Investigator for any major research Project (duration three years or above); and
 - e. Administrative Experience of minimum 3 years as Vice Principal or Head of the Department or Deputy Medical Superintendent or Medical Superintendent.
6. **Process of Recruitment:** The selection procedure will be notified later on by issuing a notice. The Board will decide the procedure for selection in respect of the posts on the basis of the number of applications received.
7. **Process to Apply:**

To apply online visit <https://nhm.assam.gov.in> -> Recruitment -> **Medical and Health Recruitment Board, Assam.**

Candidates must use their mobile number and password to login.

After that, candidates can fill up the form for that given post.

Once you have submitted the form, no further changes will be applicable.
8. **Application fees:**

Application must be accompanied with required application fee of Rs. 250/- (rupees two hundred fifty) only for General category candidates and Rs. 150/- (rupees one hundred fifty) only for OBC/MOBC/SC/ST (P)/ST (H) candidate.

No application fee is required for candidates having PWD certificate.

Application fee should be deposited only, through Treasury Challan in the Head of Account “0210-Medical and Public Health-01-Urban Health Services-800-Other Receipt”. The fees are not refundable and no other mode of deposit of fee other than through Treasury Challan, shall be accepted.

OR

Fees can be deposited online using Government Receipt Accounting System-GRAS (Website: <https://assamegras.gov.in>). Candidates may pay the requisites fees (as admissible for the category mentioned above). Printed copy of Treasury Challan generated through GRAS should be submitted at the time of interview. In Remarks column, candidate may write the post applied for.

9. Terms and Conditions:

- i. Candidates need not submit any testimonials/certificate at the time of submission of online application. However, candidates have to produce their original testimonials regarding educational qualification, date of birth, caste, PWD, Treasury challan, working experience etc. along with the application form, at the time of interview. Self-attested copies of all testimonials/certificates will have to be submitted to the Board at the time of interview.
- ii. Application form, which is incomplete in any respect, such as, without photograph and signature, is liable to be rejected summarily.
- iii. Only those candidates who fulfill all the terms and conditions of the advertisement in respect of the post for which they are applicants shall be entertained. Others need not apply.
- iv. Candidates who are in Govt. service (both State & Central) or in Govt. owned undertaking or other similar organizations etc. shall have to produce “No Objection Certificate” from the present Employer at the time of document verification, before Viva-Voce/Interview and they will have to submit release order at the time of joining.
