Duties and Responsibilities:

- Field survey, species identification and sample plot studies.
- Data collection, data analysis, preparation of reports and relevant deliverables related to various flora / faunal species in the concerned Division.
- Other additional tasks as assigned by Working Plan Officer.

Mode of Selection:


