#### **1. Eligibility Qualifications for the post of Associate Professor in M.B.A. :-**

(a) Ph.D./ Equivalent Degree in the relevant field and first class or equivalent at Master's Level in the relevant branch.

(b) Minimum of Eight Years of Experience in Teaching / Research / Industry out of which at least Two years shall be post Ph.D. Experience.

(d) Preferred age is below 50 yrs

(e) Experience of independently handling management institute is highly desirable

#### **2. Eligibility Qualifications for the post of Assistant Professor in M.B.A. :-**

(a) Any Bachelor Degree & MBA or equivalent with first class or equivalent.

(b) PhD /equivalent qualification or perusing doctoral qualifications is desirable

(C) 4-6 yrs of industry/teaching/research experience is essential.

1. Please note that the appointment to the above posts in the University is on Temporary Basis for Academic Session 2026-2027. Salary will be as per AICTE / UGC /University Norms.
2. A person selected will be permissible to avail only 8 general leave during the academic session. No other leave and allowances are permitted to the person selected.
3. Candidates must read all the instructions before filling the application form in a prescribed "Format of Application" from the University website <https://litu.edu.in>. Candidates must ensure that no column is wrongly filled in Application form as the information furnished therein would be used for deciding the eligibility and suitability of the candidates appearing for the interview. Applications not in the prescribed form or incomplete or not submitted as per the instructions herein shall be treated as invalid and shall be liable to be rejected and the responsibility of such rejection shall be on the candidate himself/herself.
4. Prescribed qualifications would be as per the Norms / Regulations AICTE/UGC & as amended from time to time and as approved by Government of Maharashtra.
5. An applicant is required to submit separate application for each post.
6. APPLICANT IS REQUIRED TO SUBMIT APPLICATION FORM ALONG WITH THE RELEVANT DOCUMENTS OF CASTE CATEGORY, IF ANY.

Self-attested copies of the certificates shall be attached in support of information given in the application form wherever necessary and serial no. of enclosures shall be indicated in the relevant column of the application form. All the information contained in the application form shall be substantiated by supporting documents.
8. Where the University has followed grading system, the candidate must obtain certificate from competent authority of the University certifying the percentage of marks obtained by the candidate.
9. Selection will be made on the basis of candidate's academic performance along with his/her performance in the interview. The University may also utilize seminar/colloquium and/or any other mode as a method of selection.
10. DULY FILLED IN "PROFORMA A", SUPPLIED ALONG WITH THE APPLICATION FORM, SHALL ALSO BE SUBMITTED ALONGWITH THE APPLICATION FORM. FAILURE TO SUBMIT "PROFORMA-A WOULD MAKE THE APPLICATION LIABLE FOR REJECTION.
11. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently-abled [(a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness] for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
12. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
13. A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
14. Candidates must attach self-attested copies of caste validity certificate and non-creamy layer certificate, wherever applicable.
