A walk-in-interview for appointment to the post of Junior Resident on ad-hoc basis for a period of 89 days or till regular candidate joins whichever is earlier, will be held in the Conference Room of this hospital on 13.04.2026 (Monday).

All eligible candidates fulfilling the criteria are requested to appear for the Walk-in-Interview on the scheduled date and time alongwith filling the attached application/ Performa with self-attested copies of testimonials and one recent passport-size photograph. Original certificates/documents are also required at the time of interview for verification. Registration shall be open between 09:00 A.M. to 11:00 AM. No candidate shall be entertained after 11:30 AM.

ELIGIBILITY CRITERIA FOR THE POST OF JUNIOR RESIDENT [MBBS]:-

1. **Qualifications:-** MBBS degree from recognized University/Institute must have valid registration certificate with medical council. Foreign Graduates must have cleared FMG Examination. Candidate must have not completed one year Junior Residency from any Govt. Hospital
2. **Internship:-** The candidate should have completed compulsory rotating internship after 13.04.2024 (on and after).
3. **Pay Scale:-** Pay Matrix of Level-10(Rs.56100-177500)+NPA+ Usual allowances as admissible from the time to time.
4. **Age Limit -** 30 years as on date of interview for General candidates, 35 years in case of SC/ST and 33 years in case of OBC.
5. OBC/ EWS certificate issued by the competent authority of Govt. of NCT of Delhi be accepted and the same have been issued before the date of interview. Further, the OBC certificate must possess Non creamy Layer certificate for the current year along with his/her cast certificate.
6. Junior Residents who have completed one year of Junior Residency shall also be allowed to appear in the Interview and will be offered residency only if fresh candidates for the post of Junior Residents are not available. There would be no extension for any Junior Resident beyond one year of appointment under relaxed provisions (vide Circular No. F. 121/26/2010/H & FW/1996-2045 dated 10.06.2011).
7. Post Graduate doctor who are interested to serve as Junior Residents will be allowed to join as Junior Residents, if fresh graduate are not available.

8. Hostel Accommodation is compulsory for Junior Residents; No HRA will be paid if the candidate stays out side.
8. Appointment will be subject to verification of certificates of educational qualification/age/caste/DMC registration and internship completion certificate etc.
9. There is no fee for appearing in the interview.
10. No TA/DA will be given for appearing in the interview.
11. Number of vacant posts may vary.
12. Reservation for person with disability candidates/Differently abled persons shall be as per rule of Govt. of India.
13. In case of any inadvertent error detected at a later stage the same will be rectified as per Rule.
14. Competent authority reserves the right of any amendment or cancelation of the advertisement at any stage.
15. Jurisdiction of dispute in case of any legal dispute the jurisdiction of court Delhi/New Delhi only.
16. Appointment will be initially for a period of 89 days, extendable up to maximum of one year on the basis of satisfactory work & conduct report from the concerned HOD on request from the doctor concerned.
17. Selected candidates shall be allowed to join immediately or maximum within 07 days of issue of the offer letter failing which the offer shall stand automatically cancelled. Hence, only those candidates who can join immediately need to apply.
18. The posts are to be filled up on ad-hoc basis strictly on merit basis.

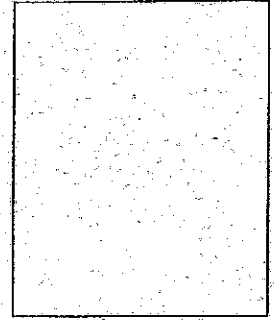
