INTERVIEW FOR POST OF ASSISTANT EXECUTIVE ENGINEER (CIVIL)

(under Water Resources Department)

In connection with the **Advertisement No. 03 of 2015-16** for the recruitment of **657** numbers of **Assistant Executive Engineer (Civil)**, the Final Result of which was already published on **01.02.2016** and appointment given by the Govt., the Hon'ble High Court while disposing the W.P. (C) No. 8290 & 15877 of 2016 filed by the State, in its order dated 14.05.2024 upheld the orders dated 22.03.2016 of Hon'ble OAT in O.A. No. 3633 (C)/2015, O.A. No. 3551 (C)/2015, O.A. No. 2652 (C)/2015 and O.A. No. 2653 (C) 2015 so far as it relates to preparing the merit list, **(i)** by restricting reservation to the extent of 50% and **(ii)** by deleting the incorrect questions/questions out of syllabus (faulty questions) and add/allot *pro rata* marks.

2. In order to comply with the orders of the Hon'ble High Court, the Department of Water Resources on 07.04.2026 submitted a revised requisition of 657 posts restricting reservation to 50% as follows.

3. The Commission has revised the marks of all candidates by allotting *pro rata* marks for the out of syllabus/ wrong questions on the basis of the Written Examination held on 30.08.2015 as per the orders of the Hon'ble Court and shortlisted candidates for Interview as per the revised requisition of vacancies indicated *supra* on the revised marks. Excluding the shortlisted candidates who have already appeared the Interview, there are **220 candidates** shortlisted afresh who were not called for Interview.

4. Now, the Commission invites such 220 candidates for the Interview to be held in the Office of the Commission at 19, Dr. P.K. Parija Road, Cuttack-754001 from **04.05.2026** to **06.05.2026** as per the Programme mentioned below.

2. Procedure before Interview:-

- i. **For transparency measures, allotment of the Interview Board will be on the basis of a draw of lots by each candidate in the presence of all candidates.**
- ii. **The draw of lots for the 1st sitting will be held in the Reception Hall from 8:30 A.M. to 9:15 A.M. and 2nd Sitting from 12:15 P.M. to 12:45 P.M.**
- iii. **Candidates who do not turn up before the closure of the draw of lots will be allotted Boards through the draw of lots by any one of the candidates present.**
- iv. **Like all other Interviews conducted by OPSC, this Interview process is also identity less and any personal particulars like Name, Roll Number or any information which might divulge the identity of candidates are not disclosed to the Interview Board. The candidate will appear for the Interview with a Code Number randomly generated through the system.**
