EDUCATIONAL NOTICE

COMMON ENTRANCE EXAMINATION FOR ADMISSION INTO B.Sc. NURSING/ D. PHARM/ B.PHARM AND ALLIED & HEALTHCARE (B.SC. MEDICAL TECHNOLOGY) COURSES IN BOTH THE GOVERNMENT AND PRIVATE INSTITUTES OF ASSAM FOR THE SESSION 2026

In pursuance of the Assam Gazette Notification No. MER. 206054/786 dated 07-11-2023 and No. MER. 488929/19 dated 26-07-2024, the Entrance Examination for selection of candidates for admission into **B.Sc. Nursing/D. Pharm/B.Pharm/Allied & Healthcare (B.Sc. Medical Technology) Courses** in both the Government and Private Institutes of Assam for the session 2026 is scheduled to be held on **07-06-2026**. Online Application Forms shall be available on University website from **20-03-2026 to 30-04-2026**.

A requisite entrance examination fee (non-refundable) shall have to be paid by the candidates only in online mode through the payment gateway available in the University website. The above examination fee is exempted for PwD (Divyang) category of candidates having disability of 40% and above.

The details of the Entrance Examination including eligibility criteria and requirements shall be available in the University website.

The Entrance Examination will be held in the centres at Guwahati, Dibrugarh, Silchar, Jorhat, Barpeta, Tezpur, Diphu, Lakhimpur, Nagaon, Kokrajhar, Nalbari, Dhubri, Shillong, Aizawl, Itanagar, Agartala, Imphal, Dimapur and Gangtok. Finalization of examination centres in the state capitals of other North – Eastern states will depend on the number of applicants applying for respective state capitals for appearing in the examination and receipt of consent from the respective State Authorities.

Admit Cards will be available online from **20-05-2026** which can be downloaded after log in.

The online Application Form must be filled up after carefully going through the instructions given along with the Form. Candidates are strictly advised to keep record of the Application Number and Password used by them while submitting the online form, without which they will not be able to download Admit Cards.

DETAILS OF THE COMMON ENTRANCE EXAMINATION (CEE) 2026

1. The Entrance Examination shall be held on **07-06-2026 (From 10AM to 12 Noon)**
2. There shall be 1 (one) paper consisting of 100 objective type Multiple Choice Questions (MCQs) of English, Physics, Chemistry, Biology or Mathematics.
3. The candidates opting for B.Sc. Nursing and Allied & Healthcare courses must mandatorily choose English, Physics, Chemistry and Biology. The candidates opting for Pharmacy courses must mandatorily choose English, Physics, Chemistry and one subject i.e. **either Biology or Mathematics. No choice of subjects shall be changed once the online application is submitted.**
4. Questions shall be of HS (10+2) Science standard.
5. Distribution of marks will be: English – 25 marks, Physics – 25 marks, Chemistry – 25 marks, Biology (Biology or Mathematics for Pharmacy courses) – 25 marks.
6. Merit shall be prepared based on the total marks obtained by each candidate in all the subjects i.e. English, Physics, Chemistry, Biology (Biology or Mathematics for Pharmacy courses).

If two or more candidates secure the same marks in the Entrance Examination, the inter-se-merit of such candidates shall be determined in order of preference as follows:

- a. Candidate securing more marks in Biology (Biology or Mathematics for Pharmacy courses) in Entrance Examination.
 - b. Candidates securing more marks in Chemistry in Entrance Examination.
 - c. Candidates securing more marks in Physics in Entrance Examination
 - d. Candidates securing more marks in English in Entrance Examination
 - e. If it further tallies then marks obtained in Biology (Biology or Mathematics for Pharmacy courses), then Chemistry, then Physics, then English of qualifying examination (HS) shall be considered at the time of counselling.
7. The minimum qualifying criteria/cut off score in the Entrance Examination of B.Sc. Nursing/Pharmacy/Allied & Healthcare Courses shall be notified at the time of declaration of result.

B. The eligibility criteria for appearing in the entrance test and for admission into B.Sc. Nursing/Pharmacy/Allied & Healthcare Courses are as follows:

1. For B.Sc. Nursing:

- a. Applicant must be a citizen of India.
- b. Permanent Resident Certificate is mandatory for admission in the Govt. Institutes of Assam.
- c. Male candidates are not eligible for admission in the Govt. Institutes of Assam.

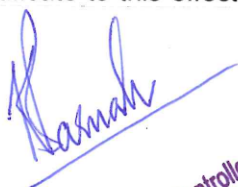
- d. The minimum age for admission shall be 17 years on 31st December of the year in which admission is sought. The maximum age limit for admission shall be 35 years.
- e. Minimum Educational Qualification a) Candidate with Science who have passed the qualifying 12th Standard examination (10+2), must have obtained a minimum of 45% marks in Physics, Chemistry and Biology taken together. In respect of candidates belonging to SC/ST/OBC the marks obtained in three core subjects shall be 40% instead of 45% for General Category candidates. The candidate must have pass marks in English. b) Candidates are also eligible from State Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government having Science subjects and English only. c) English is a compulsory subject in 10+2 for being eligible for admission to B.Sc. (Nursing).
- f. The candidates must pass both Theory and Practical individually in Physics, Chemistry and Biology.
- g. Colour blind candidates are eligible provided that colour corrective contact lens and spectacles are worn by such candidates.
- h. Candidate should be medically fit.
- i. Married candidates are also eligible for admission.

2. For Pharmacy courses:

- a. Applicant must be a citizen of India.
- b. Permanent Resident Certificate is mandatory for admission in the Govt. Institutes of Assam.
- c. Candidate must have passed Higher Secondary (10+2) Science or Equivalent Examination with English, Physics, Chemistry and Biology and/or Mathematics from recognized Board/Council/University without grace marks. However, the students passing 10+2 qualification from non – formal and non – class rooms based schooling such as National Institute of Open Schooling, open school system of States etc. shall not be eligible for admission to B.Pharm Course.
- d. The candidates must pass both Theory and Practical individually in Physics, Chemistry and Biology/Mathematics without grace mark, as applicable.
- e. Candidate must be medically fit.
- f. Candidate must be a minimum of 17 years on 31st December of the year in which admission is sought.

3. For Allied & Healthcare courses:

- a. Applicant must be a citizen of India.
- b. Be a Permanent Resident of Assam for admission in Govt. Institutes and must furnish a Certificate to this effect for admission into Govt. Institutes. The provision



of Permanent Resident Certificate shall not be applicable to the Sons/Daughters of the employees of the Govt. of Assam.

- c. The minimum qualification for selection of the candidates is H.S.S.L.C (Science) (10+2) or equivalent with Physics, Chemistry and Biology with English as one of the subjects and securing at least 45% marks aggregate in Physics, Chemistry and Biology for General Category candidates and 40% for candidates belonging to OBC/MOBC (NCL)/SC/ST(P)/ST(H) category **without grace marks**.
- d. The candidates must pass both Theory and Practical individually in Physics, Chemistry and Biology without grace marks.
- e. Candidate must be medically fit.
- f. Candidate must be a minimum of 17 years on 31st December of the year in which admission is sought.

Allied & Healthcare courses for admission in session 2026: The curriculum shall be as per National Commission for Allied & Healthcare Profession (NCAHP) for the following courses.

SI No.	Name of the Course as per National Commission for Allied & Healthcare Profession
1	Bachelor of Medical Laboratory Sciences
2	Bachelor in Medical Radiology and Imaging Technology
3	Bachelor of Emergency Medical Technologist
4	Bachelor in Anaesthesia and Operation Theatre Technology
5	Bachelor in Dialysis Therapy Technology
6	Bachelor of Physiotherapy (BPT)
7	Bachelor of Optometry (B.Optom)

* Inclusion of any further course at the time of counselling/ admission shall be as per notification of curriculum by NCAHP.

C. Reservation of seat: There shall be reservation of seats in Govt. Institutions for SC/ST(P)/ST(H)/OBC(NCL)/TGL/Ex-TGL/EWS/PwD(Divyang)/NEC category from the available seats as per Govt norms.

IMPORTANT:

It is the responsibility of the applicant to furnish all information correctly. Any information given by the applicant if found to be false or any ineligibility criteria detected at any stage later on shall make him/her liable to be disqualified from the Entrance Examination with all its associated consequences.

For candidates appearing for admission into Pharmacy courses, Question No.1 to 75 in the Booklet and OMR Sheet (English, Physics, Chemistry) shall be mandatory. Question No. 76 to 100 shall have two parts, one Biology and another Mathematics. The candidates are to answer any one of the parts as per the subject opted at the time of application.

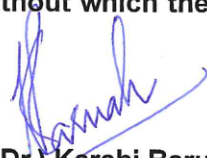
A candidate who desires to be considered under reserved category shall have to furnish original certificate of the concerned category from the Competent Authority at the time of counselling.

A candidate applying under PwD (Divyang) Category will have to produce applicable Certificate from the State Level Medical Board/District Level Medical Board as constituted in pursuance of Social Welfare Departments Notification No. SWD.181/96/75 dated 21-06-1990.

The candidates who are waiting for their HS (Science) final year result, will be provisionally allowed to appear in the entrance examination on successful submission of online application form, subject to uploading of HS (Science) marks on the online portal as and when the result is declared by the concerned Board/ Council.

As the form is to be submitted online, the candidates are not required to send any document to the University. All necessary verification/scrutiny of the related documents of the candidates regarding eligibility, reservation etc. will be done at the time of counselling by the concerned authority.

Candidates are strictly asked to keep record of the Application Number and Password used by them while submitting the online form, without which they will not be able to download Admit Cards.
