**ADVERTISEMENT**

**Sub: - Recruitment of CT (GD) through remusteration.**

Applications are invited from serving (Male & Female) Combatised CTs (Tradesmen i.e. Tailor, Cobbler, Cook, Barber, Washerman, Safaiwala, Gardener, Water Carrier, Waiter and Helper) and CT (Orderlies) of SSB to **fill up 50 vacancies** of the year-2026 of Constable (General Duty) through remusteration as per details given below :-

**Note: - i) Vacancies are subject to change and may increase or decrease without any notice.**

**ii) DG, SSB reserves the right to cancel/ postpone the above recruitment without assigning any reason.**

**2. Eligibility criteria to apply for the post: - Constable (Tradesmen) and Constable (Orderlies) who fulfill the following conditions are eligible for CT (GD) through remusteration: -**

- a) Complete minimum 3 years of regular service in SSB as on 01.01.2026.
- b) The crucial date to determine the completion of 3 years regular service as CTs (Tradesmen) & CTs (Orderlies) in the force will be 1<sup>st</sup> January 2026.
- c) Essential Educational qualification: - Matriculation or equivalent from a recognized board or institute.
- d) Have a latest medical category SHAPE-I.
- e) Have a clean service record in the preceding 3 years of service for the vacancy year 2026.
- f) APAR grading for preceding 3 years (i.e. 2022-23, 2023-24 & 2024-25) should not be below "Good" benchmark (not below 04 numbers in APAR).
- g) The cut off date for determining the eligibility criteria will be **01/01/2026**.

**3. Age limit: - Upper age limit for appearing in recruitment for the post of CT (GD) through remusteration is below 35 years for UR and OBC category candidates as on **01/01/2026**. However, upper age limit shall be relaxable by 05 years only for the SC/ST candidates.**

4. **RECRUITMENT PROCESS & STAGES: -**

The recruitment for the post of CT (GD) through remusteration will be conducted as per following: -

(i) **Physical Standard Test (PST): -** All candidates issued admit cards will have to undergo Physical Standard Test (PST) followed by biometric identification as per details given below: -

**Note:** - a) A candidate not meeting the minimum height and chest requirement will be rejected from recruitment process.

b) Candidates seeking relaxation in height and chest will be required to submit the certificate regarding their community from concerned District Authorities. In the event of non-production of the certificate their claim for relaxation in height and chest will not be entertained and their candidature for the post shall be cancelled straightaway. No correspondence in this regard will be entertained by SSB at later stage. Criteria for relaxations are subjected to instructions of Government of India.

c) The height and chest measurement of a candidate will be measured correct to one decimal place in centimeter. For example height will be measured and recorded as 170.2 cm. Any candidate having height or chest measurement less than the prescribed minimum in Recruitment Rules will be disqualified. For example if minimum height for a category is 170 cm then all the candidates of such category having height 169.9 cm and less will be disqualified.

d) **Weight:** - As per MHA (Police-II) office memorandum No. 45020/03/2025-PP/28 dated 09/03/2026, normal range of BMI will be 18-25. Candidate with BMI below 18 & above 25 are to be rejected considering underweight & overweight respectively.

$$\text{Formula of BMI} = \frac{\text{Weight in KG}}{(\text{Height in meter})^2}$$

**Note:** - Weight will not be a criteria for disqualification at the time of Physical Standard Test (i.e. chest and weight measurement). However, the overweight/ underweight candidates will be disqualified at the time of Detailed Medical Examination based on weight and age on the day of Detailed Medical Examination and the height as measured during height measurement.

**Appeal against Physical Standard Test (PST):** - Candidates declared disqualified in Physical Standard Test can prefer an appeal to the appellate authority for re-measurement of Height and Chest only. The appeals of the candidates to be disposed off preferably on the same day by the appellate authority..

**(ii) Physical Efficiency Test (PET):** - The candidates found eligible in Physical Standard Test (PST) will have to undergo Physical Efficiency Test (PET) as per details given below: -

(A) i) **For Male:** - 5 Kms race to be completed within 24 minutes.

ii) **For Female:** - 1.6 Kms race to be completed within 8 minutes 30 seconds.

(B) "On reporting of female candidates for PST (Physical Standard Test) and PET (Physical Efficiency Test), a self declaration indicating about her pregnancy status shall be submitted by the candidate. In case, if she declares that she is not pregnant then, she will be allowed to participate in the PST and PET. In case of false declaration, all the risks for undergoing PST and PET will be of her own. If the female

candidate declares that she is pregnant before PST and PET, then a confirmatory pregnancy test is to be done at SSB Hospital and in case she is found pregnant, irrespective of duration of pregnancy, she will be declared temporary unfit and her candidature shall be held in abeyance until the confinement is over. Required vacancies will be kept reserved for temporary unfit candidates. She will be re-examined for PST and PET six weeks after the date of confinement is over, subject to the production of the medical certificate of fitness from a registered medical practitioner. If she qualify in all stages of recruitment and find placed in merit, she will be appointed to the post kept reserved for and allow the benefit of seniority in accordance with the instruction of the Government, as amended from time to time. In case female candidates is found negative for pregnancy, she may be allowed to participate in the PST and PET.

- (C) PST and PET shall be mandatory but will only be qualifying in nature and will not carry any marks.
- (D) SSB/Department will not be held responsible for any kind of injury, if sustained during PET and PST.

**(iii) Written Examination:** - The candidates who qualify in the PST and PET will have to appear in the written examination including those Female candidates who has been declared temporary unfit due to her pregnancy at the time of PST and PET . **The written examination** will be of 2 (two) hours and contains 100 marks, consisting 100 multiple objective type question focusing on General Awareness, General Knowledge, Knowledge of elementary mathematics, analytical aptitude and ability to observe and distinguish patterns and to test the basic knowledge of the candidates in English/ Hindi. The question paper will be bilingual i.e. in English and Hindi.

**Minimum qualifying marks for written examination will be: -**

35 % for General category candidates.

33 % for SC/ST/OBC category candidates.

**Note:** - Written Examination result of Temporary Unfit Female Candidates will be published only after qualifying the PST and PET.

**iv) Documentation and Detailed Medical Examination (DME) :** -

a) The candidates eligible for DME will have to go through documentation process, in which candidates will have to produce all original documents/certificates, the details of which he/she has given in the application form. Failing which the candidature of candidate will be rejected straightaway. No appeal on rejection during documentation process will be entertained by SSB at later stage.

b) Detailed Medical Examination will be conducted in respect of only those candidates who will score above the cut-off marks in the written test. Detailed Medical Examination will be conducted as per Revised Medical Guidelines issued by the MHA vide OM No.A.VI-I/2014/2014-Rectt(SSB) dated 20.05.2015 and amendments issued from time to time.

(v) **Review Medical Examination (RME):** - If a candidate is declared unfit in the DME, the grounds for rejection will be communicated to him/her by the Chairman of DME board. If rejected candidate is not satisfied with the findings of the Medical Officer, he/she may give the his/her consent in writing by appending their signature on the intimation indicating the reason for being unfit within 24 hours after he/she is informed of his/her unfitness in DME on prescribed proforma. After acceptance of consent letter from the candidate, RME will be conducted accordingly, preferably next day of DME.

The decision of the Review Medical Examination Board will be final and no 2<sup>nd</sup> appeal will be entertained by SSB. Further, no correspondence in this regard will be entertained by SSB at later stage.

**NOTE: -**

(a) It should, however, be clearly understood that the Selection Board reserves absolute discretion to reject or accept any candidate after considering the report of the medical board.

(b) Being declared FIT in Medical Examination will in no way give any legal claim or right to any candidate for final selection/appointment to the post of CT (GD) through remusteration as the selection will be strictly as per merit.

5. **FINAL SELECTION:** - a) After completion of document verification (DV), Detailed medical examination (DME) & Review Medical Examination (RME), the final selection list will be generated on the basis of marks obtained in written test. It is hereby emphasized that the candidate who merely secures the qualifying marks and found medically fit, may not have any right for his/her final selection since the cut off marks will be determined based on the number of vacancies of each categories after completion of whole recruitment stages & process.

b) **Tie-principle** - (i) If, two or more candidates secure the equal marks in the written test, the candidate older in age will be assigned the higher merit.

(ii) If, the tie still persists, the candidate with the longer service in SSB will be placed higher in the merit list.

6. A candidate who is or has been declared to be guilty of misconduct or misbehavior in connection with the examination may be liable: -

- (a) To be disqualified from the examination for which he/she is the candidate; and/or
- (b) To be debarred for a specified period (To be decided by competent authority at FHQ) of subsequent examination(s) and/or
- (c) To face disciplinary action under SSB Act & Rules.

7. **Venue and date of PST and PET/Written Examination/DV & DME/RME:** -


The name of venue & date for PET, PST, Written Examination, Documentation and Medical Examinations will be intimated in due course of time.

8. Concerned unit will ensure that application along with No Objection Certificate, Service Certificate, DE/Vigilance certificate and check list are enclosed herewith as Appendix – 'A', 'B', 'C', 'D' & 'E'.

9. All the units are requested to give wide publicity amongst the Force personnel and obtain their applications on the prescribed proforma (Appendix-"A") as enclosed. The SSB personnel who are on deputation or performing duties outside areas, the unit concerned will inform to eligible candidates at their present duty places and obtain their applications as per prescribed proforma for onward submission.

10. **Last date of submission of application:** - The willing and eligible candidates are required to submit their applications on prescribed proforma (copy enclosed) along with necessary documents to their respective units, as per detail given below: -

- a) Last date for submission of applications by eligible candidates to their units will be 30 days from the date of publication of advertisement. Last date for receiving application from individual will be. 20 June 2026.
- b) After proper scrutiny of applications, the unit concerned will forward the applications of eligible candidates only to their concerned **Ftr Hqr SSB** within 10 days from the last date of receipt of applications i.e. 30 June 2026.
- c) After receiving and proper scrutiny of applications at Frontier level, Ftr Hqr. will forward the applications of eligible candidates to **Application receiving Centre (ARC), at SHQ, SSB, Lakhimpur Kheri** within 10 days thereafter i.e. 1 July 2026 to 10 July 2026
- d) After proper scrutiny of applications, **Application receiving Centre (ARC) SHQ, SSB, Lakhimpur Kheri** will forward the list of eligible candidates in soft and hard copies to **FHQ (Recruitment Branch)** within 20 days thereafter i.e. 30 July 2026 for allotment of Roll Number.
- e) Applications received after **due date** at Units should not be entertained.
- f) Commandant/Head of the units will send the applications in consolidate manner of only those CTs (Tradesmen) and CTs (Orderlies) who fulfills the eligibility conditions as prescribed above to the authority concerned. Similarly, **Dy.Comdt (Estt) FHQ, Academy Bhopal, CTCs, RTCs, CHs, CSD & W etc.** will forward the applications/willingness in respect of the eligible candidates posted at their respective units to ARC within stipulated time.


