Terms of Engagement:

1. Contractual employment will be made for one year from the date of appointment. However, contract may be extended or terminated on the basis of satisfactory/unsatisfactory service without any notice.
2. Age limit for Consultant Minimum 21 years Maximum - 60 years as on 1 Aug. 2026.
3. Last date for receiving the application is 20.06.2026. Application received after last date/time will be refused/ rejected.
4. The successful candidates will be required to execute contractual agreement and their services will be guided by the service rules of NAM.
5. **How to apply:** Go to website **JAP-IT Website- <https://recruitment.jharkhand.gov.in>** then register if you are new user and login in case of existing user. After logging in select the role for which you want to apply and fill the form along with the required documents and make the payment i.e. 1,000/- for each application on the portal.


6. Required documents:

- a. Aadhar card
- b. Pan card
- c. Photograph (Passport size)
- d. 10 Mark sheet
- e. 12h Mark sheet
- f. Semester wise mark sheet of BAMS/BUMS/BHMS/BSMS/BYMS
- g. Degree certificate
- h. Experience certificate
- i. Caste certificates for ST/SC/BC I/BC II/EWS (if applicable) which should not be older than 6 months before the last date of application.
- j. Domicile/Residential Certificate (if applicable) which should not be older than 6 months before the last date of application.
7. For the posts of Consultant shortlisted candidates would be called for Document verification and Personal interview at AYUSH Directorate, RCH Campus, Namkum, Ranchi, Jharkhand 834010 on the date and time communicated to them through website <https://recruitment.jharkhand.gov.in> under Notice section) only. Personal interview will be conducted under the chairmanship of Director AYUSH.

Note : If number of Applicants increases considerably than Written Exam may be conducted by authority.

8. List of selected candidates will be published on website (<https://recruitment.jharkhand.gov.in> under notice selection) after the completion of recruitment process.
9. The selected candidates will get an annual enhancement of 05% based on satisfactory performance to be decided by the performance assessment committee of AYUSH.
10. Leave - The selected candidates will get maximum 16 days leave during a calendar year.
11. The state AYUSH society reserves the right to cancel/postpone the recruitment wholly or partly if so required No claim will be admissible in case of such cancellation/postponement.

Example for calculation of marks for merit list. Total marks-100

Name of Candidate - Z

- a. 10th (Matriculation): Z have 60% aggregate marks percentage in 10th.
Z will receive 10% of aggregate marks percentage i.e $60 \times 10\% = 6$ marks
Maximum Marks for 10th(Matriculation): **10 marks**
- b. 12th (Intermediate): Z have 60% aggregate marks percentage in 12th.
Z will receive 15% of aggregate marks percentage i.e $60 \times 15\% = 9$ marks
Maximum Marks for 12th (Intermediate): **15 marks**
- c. BAMS/BUMS/BHMS/BSMS/BYNS: Z have 60% aggregate marks percentage in Graduation.
Z will receive 30% of aggregate marks percentage i.e $60 \times 30\% = 18$ marks
Maximum Marks for Graduation: **30 marks**
- d. Post Graduation: Z have 60% aggregate marks percentage in Graduation.
Z will receive 5% of aggregate marks percentage i.e $60 \times 5\% = 3$ marks
Maximum Marks for Post Graduation: **5 marks.**
- e. Experience-Z have 4 years of working experience.
Lets say, Z is applying for Consultant NAM(Basic Essential Experience for Consultant NAM: 3Y)
For Basic Essential Experience: **5 Marks**
For each year 2 marks will be granted after completing basic essential experience, **subject to the Maximum limit of 10 marks.**
 $5 + 2 = 7$
Z will receive **7 marks out of 15.**
- f. Interview-lets say Z have been awarded with **20 marks out of 25** marks in Panel Interview
Hence, Z will be granted with **(6+9+18+3+7+20)63 marks out of 100.**

Annexure-II:

Eligibility, Responsibilities, Remuneration and Modes of Appointment

1. Consultant [2 Posts]

The said post shall be contractual in nature and appointment would be from open market.

Eligibility Criteria:

Minimum bachelor degree (BAMS/BUMS/BHMS/BSMS/BYNS) from recognized university with minimum 03 years working experience in Public Health Programmes of Government/PSUs or reputed private organization. Exposure in social sector schemes/ Mission of Government at national, state and district level and Knowledge of MS office (MS Word, MS Power Point, MS Excel) would be desirable. Performance may be given to personal having experience of working in Health sector including AYUSH.

Responsibilities:

Consultant NAM shall work as a technical support to PMU team. Main responsibilities are:

- To provide technical Inputs and support for planning, implement monitoring and outcome analysis of National AYUSH Mission including AAM-AYUSH in the State/UT.
- To provide assistance/technical inputs in preparation of State Action Plans (SAAP) as per NAM guidelines.
- To assist & provide technical support in capturing data related to NAM, its analysis and usage in Policy planning, impact analysis etc.
- To assist in conducting training/short duration orientation courses for manpower to enhance capacity.
- Assist in preparation of operational guidelines for public health outreach activity through AYUSH school health programme, AYUSH Gram, behavior change communication programme or other IEC related activities.
- To assist in updating AYUSH profile documents.
- Conducting field visits periodically in order to monitor and evaluate different activities approved & being implemented under NAM.
- To co-ordinate and assist with 3rd party evaluations team/ central monitoring team etc as and when required.
- Assist in Data validating of the information to be uploaded on the National AYUSH Mission website with the support of HMIS Manager and other PMU manpower.
- To have liaison with Central Programme management unit manpower of NAM division for desired co-ordination and follow up.
- Any other work assigned by authorities of the State /UT Govt.

Remuneration:

Rs. 60,000/- per month as consolidated remuneration with annual enhancement of 05% based on satisfactory performance to be decided by the performance assessment committee of AYUSH.

Mode of Recruitment:

The recruitment shall be on the basis of evaluation of marks, experience as well as interview.

60% weightage of marks Academics, 15% marks shall be for experience and the remaining 25% shall be given on the basis of interview.
