In obedience to the orders dated 31.10.2025 and 06.04.2026 passed by Hon'ble High Court of Orissa in WP(C) No.29894/2022 and WP(C) No.30062/2022 respectively and in continuation of Notification No.337(C)/OSSC dated 30.11.2023 and Notification No.349(C)/OSSC dated 07.12.2023 the following candidates (**11 nos.**) are provisionally selected for the post of ATO (Diploma/Degree) and ATO (ITI) relating to CTSRE-2022 pursuant to Advertisement No.6506/OSSC dated 02.11.2022.
