			<u>Age:</u> Upto 64 years as on 19/08/2026. In the case of retired Executives, only those who retired from PSUs/Government Organizations in E-06 to E-09 or equivalent pay scales shall be eligible to apply. <u>Remuneration:</u> In case of Govt./PSU employees: A consolidated amount of maximum 50% of last drawn Basic and 50% of DA element considered as fixed special allowance. In addition, an allowance of 5% (on 50% of Basic pay) of remuneration to cover expenses of conveyance, telephone, internet etc. shall be paid. The remuneration of Consultants (other than retired Government/PSU employees) shall be determined by the Competent Authority based on the recommendations of the Selection Committee, considering factors such as experience, last pay drawn, and relevant domain expertise. However, the consolidated remuneration, inclusive of all components, shall not exceed Rs. 2.00 lakh per month. <u>House Rent Allowance:</u> In the case of a full-time Consultant, Company accommodation may be provided, subject to availability. Where Company accommodation is not available, House Rent Allowance (HRA) shall be paid at the rate of 30%, 20% and 10% of the consolidated remuneration for X, Y and Z class cities, respectively.
