Terms and Conditions

For post of Forensic Advisor at CBI, Headquarters, New Delhi

**1. Essential Qualification:**

A Master's Degree in Forensic Science from a recognized university;

or

A Master's Degree in any branch of Science, Engineering, Technology, Medicine, Law, Criminology, or related discipline from a recognized university, with specialized qualifications, training or substantial experience in forensic sciences.

- 2. Total Experience:** Minimum of 2 years-Experience in providing expert forensic advice and support in criminal investigations, prosecutions, or judicial proceedings.

Candidates with experience in forensic institutions, central/state forensic laboratories, law enforcement agencies, regulatory bodies, shall be preferred.

**3. Domain Knowledge :**

- i. Should have hands-on experience in the area of forensic technology, tools & techniques
- ii. Should have knowledge of data analysis, fraud detection, audio-video analysis, cyber security

- 4. Place of posting :** CBI Headquarter, New Delhi

- 5. Remuneration:** Rs.1,00,000/- per month

- 6. Contract Period:** Initially for 1 year, extended further on yearly basis based on Performance of the candidate and requirement of CBI.

- 7. Facilities to be provided:** Functional office space and paraphernalia shall be provided for discharge of duties

**8. Instructions for Applicants:**

- i. Applicants are required to go through the Eligibility criteria carefully and ascertain themselves regarding their eligibility.

- iii. Name of the Applicant in application form must be same as mentioned in the certificate of Class X.
- iv. In case the candidate has changed his name subsequent to X, the evidence to that effect should be furnished at the time of interview.
- v. Scanned Documents to be included along with the Application form are:
  - a) Resume of candidate
  - b) Passport Size Photograph of candidate
  - c) Marksheets of Class Xth, XIIth, Graduation and or Post Graduation
  - d) Proof of Date of birth
  - e) Qualification Degree/Certificate as per requirement for the post applied
  - f) Self-attested experience certificates (including the Experience letter from the current place of working)
  - g) Govt. issued Photo Id Card (e.g. Aadhaar/ PAN/ Passport/ Voter ID etc.)
  - h) Signed and scanned copy of Self-Declaration as included in the Appendix-A:
- vi. Cut-off date for calculating age and experience shall be 01-07-2026.
- vii. Incumbent will be hired purely on contract basis initially for a period of one year which may be further extended based on performance and requirement on yearly basis.
- viii. Only short-listed candidates shall be called for interview. Applying against the advertisement does not entitle the applicant to be called for interview.
- ix. Applicants with last semester result awaited or incomplete degrees are not eligible to apply.
- x. Canvassing/trying to influence CBI employees to secure the job in any manner may disqualify the candidate.
- xi. CBI has the right to accept or reject the application without assigning any reason thereof.
- xii. A few deserving shortlisted candidates may also be kept in panel for future requirement. It does not entitle the empaneled candidate to claim as right to employment.

## **9. Confidentiality Clause**

- i. He/she must not use, publish, disclose, or share any data, statistics, proceedings

information gathered during the assignment with any third party without prior written consent of CBI.

- ii. He/she is required to sign a Non-Disclosure Agreement (NDA) with CBI.
- iii. The obligation of confidentiality and secrecy applies both during and after the contract period.
- iv. His/her role includes information security and forensic responsibilities, requiring high standards of personal conduct and strict adherence to security protocols and policies
- v. Upon termination of the contract, he/she shall be required to return all information/materials received or created and shall not retain any copies in any form

#### **10. Additional Terms and Conditions for Engagement as Consultant**

- i. The engagement shall be on contract basis initially for a period one year which may be extended further at the discretion of CBI subject to satisfactory performance and also subject to the requirement of the organization. The engagement can be terminated at any time without assigning any reason.
- ii. He/She shall be paid a consolidated fee (inclusive of all) per month as prescribed subject to TDS at applicable rates. He/She shall devote whole of his/her time for the organization and he/she shall not accept any other professional appointment, paid or otherwise during the period of contract.
- iii. He/She shall perform the duties assigned by the concerned officer In-charge or his/her nominee from time to time. He/She shall maintain absolute secrecy of all the facts and documents which come to his/her knowledge during the period of his/her engagement in the discharge of duties assigned to him/her at all times.
- iv. If the incumbent intends to leave the Organization before the completion of the Contract period, he/she shall be required to give prior notice of 2 months.
- v. He/She will be entitled for 08 Casual Leave and 02 Restricted Holiday in a year. No other leave of any kind shall be admissible to him/her.
- vi. In case he/she remains absent from duty, a proportionate deduction from the consolidated remuneration. The engagement can also be terminated in case of regular absence.
- vii. In addition to the normal working days, if he/she may be required to attend the office on Saturday/Sunday and other holidays in exigencies of work without any additional remuneration. However, duties done during holidays or weekend may be adjusted for

extra leave availed.

- viii. He/She may be required to travel locally or outstation as and when job requires. During the travelling on Tours, reimbursements shall be made as per applicable rule for level-7 in Government of India.
- ix. He/She shall not be entitled to pay, perks and other facilities admissible to regular employees of CBI during the Contract period or any time thereafter.
- x. He/She is expected to maintain decorum, discipline and punctuality in the office.
- xi. He/She shall be required to intimate residential address during the period of engagement in CBI and update the office in case of any change.
- xii. If any declaration or information furnished by him/her proves to be false or if he/she is found to have willfully suppressed any material information, he/she will be liable to termination of the contract.
- xiii. He/she must not have any criminal antecedents.

#### **11. Termination of Engagement**

CBI may terminate the engagement under the following conditions:

- i. If he/she is found lacking in honesty and integrity.
- ii. If he/she is involved in any criminal case.
- iii. If any new adverse information comes to light after appointment that negatively impacts CBI, or Your ability to discharge duties.
