Age Seniority: If the percentage (%) of marks in professional qualifications are also identical, the candidate who is older in age will be placed above the younger candidate. c. Higher Secondary (+2) Marks: If the candidates share the exact same birth date, the candidate who secured higher marks in +2 (in any stream) or an equivalent examination will be ranked higher. d. Commission's Discretion: In case the tie still remains unresolved after all the above steps, the Commission reserves the absolute power to decide any other criteria to break the tie.
