

## HIMACHAL PRADESH RAJYA CHAYAN AAYOG, HAMIRPUR

### PRESS NOTE

Himachal Pradesh Rajya Chayan Aayog today declared the result of Computer Based Screening Test for the recruitment of 156 posts {Gen(UR)-56, Gen(EWS)-20, Gen(WFF)-02, OBC(UR)-25, OBC(BPL)-06, OBC(WFF)-01, SC(UR)-31, SC(BPL)-06, SC(WFF)-01, ST(UR)-06, ST(BPL)-02} of **Teacher Commerce (on Engagement Basis), Post Code-26020**, which was held on 14.07.2026. The result of the same has been compiled as per the award lists and ratio approved by the Hon'ble Aayog. The requisition to fill up these posts was received from the Director of School Education, HP Shimla-01 and advertised vide advertisement No. 07/2026 dated 07.04.2026.

In response to this advertisement, 1734 applications were received and all were provisionally admitted. Further, 1451 candidates appeared in the Computer Based Screening Test and 283 candidates remained absent.
