

HIMACHAL PRADESH RAJYA CHAYAN AAYOG, HAMIRPUR

PRESS NOTE

Himachal Pradesh Rajya Chayan Aayog today declared the result of Computer Based Screening Test for the recruitment of 108 posts {Gen(UR)-41, Gen(EWS)-14, Gen(WFF)-01, OBC(UR)-17, OBC(BPL)-04, SC(UR)-21, SC(BPL)-04, SC(WFF)-01, ST(UR)-04 AND ST(BPL)-01} of Special Educator (Pre-Primary to Class-V) (On regular basis), Post Code-25022, which was held w.e.f. on 27.05.2026. The result of the same has been compiled as per the award lists and ratio approved by the Hon'ble Aayog. The requisition to fill up these posts was received from the Director of School Education, HP Shimla-01 and advertised vide advertisement No. 06/2025 dated 28.11.2025.

In response to this advertisement, 663 applications were received and all were provisionally admitted. Further, 643 candidates appeared in the Computer Based Screening Test and 20 candidates remained absent.

Documents' verification regarding eligibility etc. of the shortlisted candidates will be conducted w.e.f. 20.08.2026 at 10.00 AM onwards in the premises of the HP Rajya Chayan Aayog, Hamirpur. The candidates are directed to bring all the original eligibility related documents, 02 sets of self attested copies of all documents, one ID proof and copy of downloaded Application Form. In case a candidate fails to appear on the day fixed for

document verification, he/she will not be considered for further selection process and **no further opportunity will be given thereafter**. The schedule for document verification shall be uploaded on the official website of HPRCA in due course. The candidates shall also be intimated through their respective email Id's as made available/provided by the candidates to the HPRCA. No separate call letters shall be sent by post in this regard.

The result is declared subject to the final outcome of CWP No. 6967 of 2025 titled as Som Krishan Vs State of HP and Ors.

The result is also available on the official website of the HPRCA, Hamirpur (<http://www.hprca.hp.gov.in>).

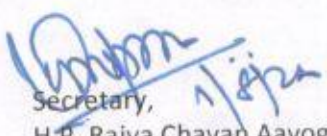
While every care has been taken in preparing the result, possibility of inadvertent/technical error cannot be ruled out. The Aayog reserves the right to rectify the same later on.
