SUBJECT : ADVERTISEMENT FOR APPOINTMENT / ENGAGEMENT OF SPECIAL PUBLIC PROSECUTOR TO CONDUCT TRIAL OF LOKPAL REFERRED CBI CASES IN TRIAL COURTS AT **LUCKNOW - REGARDING.**

1. CBI Policy Division, New Delhi intends to create a panel of advocates for conducting trial of Lokpal referred cases pending trial before Special Judge, CBI, Ghaziabad. In this regard, applications are invited from the eligible advocates for engagement as Special Public Prosecutor in CBI to conduct Trial at **Special Judge, CBI, Lucknow.**
2. **PROFESSIONAL FEE** - The Professional fee of the Advocates will be governed by the terms & conditions contained in DoPT File No. 225/19/2023-AVD-II Dated 08.04.2024 (copy attached).
3. **ELIGIBILITY CRITERIA** - The following points may be kept in view while submitting the request for the appointment /engagement of CBI Special Public Prosecutors to conduct CBI cases before the Trial Courts: -
 - i) Educational Qualification: LLB
 - ii) Enrollment Certificate as an Advocate with the Bar Council.
 - iii) Experience at BAR of handling criminal matters in Sessions Courts.
 - iv) An unconditional willingness/consent to work on the general terms & conditions approved by Government of India from time to time.
 - v) Details of important cases handled by the applicant advocates. A minimum standing of 10 years as an Advocate is required for considering an Advocate for CBI Special Public Prosecutor, who have experience in handling criminal matters.
 - vi) **Experience in conducting trials of cases under the Prevention of Corruption Act, 1988, is mandatory pre-condition.**

vii) **Eligible candidates shall be required to be stationed at the place where the concerned Court is situated. No travelling allowance or reimbursement of travel expenses shall be admissible for attending the Court.**

4. **PERIOD** - Minimum 3 years.

5. **NATURE OF JOB** - To conduct trial of cases pending under trial in the court of Special Judge, CBI, Lucknow.

6. **DOCUMENTS TO BE SUBMITTED ALONGWITH THE APPLICATION –**

The following documents may be submitted along with the application: -

- i) Educational Qualifications
- ii) Enrollment Certificate as an Advocate with the Bar Council.

- v) Details of important cases handled by the applicant advocates.
- vi) **Details of case under Prevention of Corruption Act, 1988 handled by applicant advocates.**

Incomplete applications and applications submitted offline shall not be considered. Further, no application shall be entertained by CBI, which are submitted after last date of submission of application. Only shortlisted candidates will be called for an interaction by CBI
