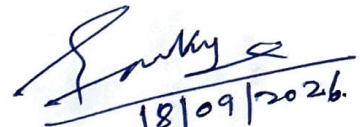

2. **The Selection Committee may, based on the qualifications, experience and performance of the candidate, consider a candidate appearing for SRA for engagement as JPF, subject to fulfilment of the prescribed eligibility conditions for JPF. Accordingly, candidates, including freshers, may also appear for the SRA position; however, candidates fulfilling the prescribed SRA eligibility conditions shall be given preference for engagement as SRA.**
3. Registration of eligible candidates shall be conducted from 09:00 A.M. to 09:30 A.M. only. No candidate reporting after 09:30 A.M. shall be registered.
4. Candidates shall bring the duly filled application form in prescribed format, one recent photograph, ID proof (Masked Aadhaar/PAN Card/Voters' ID), Original Certificates/Documents and their Self-Attested Photocopies thereof. No request for photocopying/printing of documents shall be entertained at DESM. Therefore, it is in candidate's own interest to bring the photocopies.
5. Candidates working in other organisation shall produce a No Objection Certificate (NOC) at the time of interview.

7. No TA/DA shall be paid for attending the interview or for joining the position.
