PRESS NOTE

Himachal Pradesh Rajya Chayan Aayog today declared the result of Computer Based Screening Test for the recruitment of 236 posts {Gen(UR)-38, Gen(EWS)-26, Gen(WESM)-27, Gen(WFF)-04, OBC(UR)-43, OBC(BPL)-10, OBC(WESM)-06, OBC(WFF)-01, SC(UR)-47, SC(BPL)-10, SC(WESM)-10, SC(WFF)-03, ST (UR)-05, ST(BPL)-03 & ST(WESM)-03} of **Operation Theatre Assistant** (Job Trainee) Post Code-**26008** which was held on 14.08.2026. The requisitions to fill up these posts were received from the Director, Health Services H.P. & the Director, Medical Education & Research H.P. and advertised vide advertisement No. 04/2026 dated 28.02.2026 & Addendum dated 10.07.2026.

In response to this advertisement, 202 applications were received and all were provisionally admitted. Further, 184 candidates appeared in the Computer Based Screening Test and 18 candidates remained absent.
